All applicants must be eighteen (18) years of age or older

FEES - MUST ACCOMPANY APPLICATION:

Make remittance payable to the CONSTRUCTION INDUSTRIES BOARD or CIB

Electrical Contractor \$330.00 (License \$300.00 / Processing \$30.00)

Electrical Journeyman (Reciprocal or otherwise) \$75.00 (License \$50.00 / Processing \$25.00)

LIMITED ELECTRICAL CONTRACTOR EXAMINATION REQUIREMENTS

This person is prohibited from engaging in the work of an apprentice or journeyman electrician

 Degree in Electrical Engineering from an accredited college or university and 8,000 hours of electrical experience in field construction, electrical estimating, electrical project management in commercial/industrial electrical work,

OR

- Verification of 16,000 hours experience in the electrical trade performing electrical work, estimating or project management in commercial/industrial work.
 - (Must be an Owner, Partner, or Officer in the electrical firm after obtaining and activating license)

UNLIMITED ELECTRICAL CONTRACTOR EXAMINATION REQUIREMENTS

- 12,000 Verifiable Hours on the job experience in electrical construction work while employed by a licensed electrical contr.
- Proof of 4,000 hours and 2 years experience as licensed unlimited electrical journeyman employed by a licensed elec. contr.
- 6,000 hours must be in commercial industrial work obtained while employed by a licensed electrical contractor
- 2,000 hours maximum may be satisfied by formal electrical education*
 - (Must be an Owner, Partner, or Officer in the electrical firm after obtaining and activating license)

UNLIMITED ELECTRICAL JOURNEYMAN EXAMINATION REQUIREMENTS

- 8,000 Verifiable hours on the job experience in electrical construction work while employed by an electrical contractor and registered as an apprentice under the direct supervision of a licensed journeyman or licensed contractor
- 4,000 hours must be in commercial/industrial work
- 2,000 hours may be satisfied by formal electrical education*

RESIDENTIAL ELECTRICAL CONTRACTOR EXAMINATION REQUIREMENTS

(Residential electrical licenses are limited to wiring one and two family dwellings)

- 8,000 verifiable hours total in electrical construction work while employed by an electrical contractor
- 4,000 hours as a residential or unlimited journeyman electrician under the employment and supervision of an electrical contractor
- 4,000 hours as a registered apprentice under the employment and supervision of an electrical contractor **OR**
- 3,000 hours as a registered apprentice and 1,000 hours may be satisfied by formal electrical education*
 - (Must be an Owner, Partner, or Officer in electrical firm)

RESIDENTIAL ELECTRICAL JOURNEYMAN EXAMINATION REQUIREMENTS

(Residential electrical licenses are limited to wiring one and two family dwellings)

- 4,000 Verifiable hours on the job experience in electrical construction work while employed by an electrical contractor and registered as an apprentice under the direct supervision of a licensed journeyman or licensed contractor.
- 1,000 hours may be satisfied by formal electrical education*

REFINERY ELECTRICAL JOURNEYMAN EXAMINATION REQUIREMENTS

(Refinery electrical licenses are limited to wiring inside Refinery facilities that are defined as facilities designed and operated to receive, unload, store, process and refine raw crude oil.)

A verifiable license in the unlimited electrical classification issued by a jurisdiction outside of the State of Oklahoma that is:

- i. current, and
- ii. in good standing.

*Educational Experience must be actual class room hours verified with an official transcript

GENERAL INSTRUCTIONS

Applicants for Electrical License should make themselves familiar with The Electrical License Act and the Rules and Regulations. The application must be completed and signed by the applicant. An application is not considered complete and will not be processed until all items have been submitted as required. All information provided must be typed or legibly printed in ink. Attachments must be submitted on separate pieces of single-sided, 8½" x 11" paper. Please use a paperclip to fasten all pages together, with the check or money order on top. **Do not use staples**.

Completion

- 1. Your application must be complete. Check the box at the top right hand corner of the application for the license for which you are applying.
- 2. Your signature and "Affidavit of Lawful Presence" must be notarized. (Original ink no copies or digital signatures)
- 3. Work history must be completed for <u>all types</u> of electrical license. Provide a complete work history with all blanks filled out. If a company that you have worked for is out of business, state so on the form. (You may duplicate the work history form as many times as is necessary to be complete.)
- 4. Experience affidavits must be provided and signed by the employer(s) in original ink (no copies or digital signatures). Any non-employer must provide information describing how he has knowledge that you worked those hours. Making a false statement in the application for a license may result in suspension, revocation, and/or prosecution for perjury. (You may duplicate the affidavit of experience form as many times as is necessary to be complete.)

Experience

- 5. Oklahoma residents must have been registered as an apprentice to accumulate the requisite hours for a Residential Journeyman or Unlimited Journeyman license.
- 6. Out-of-state residents must have completed similar experience requirements and include a front and back copy of apprenticeship registrations or all government issued electrical license(s).
- 7. Utility electrical work is <u>not</u> counted as experience. Education can only count a maximum of 2000 hours.
- 8. To obtain educational credit you must present official transcripts, classroom hours attended, grades, and certificates of approved course(s).
- 9. You may be asked to provide tax records or a social security earnings report if hours are irregular or in cases where the experience was obtained from companies that are now out of business.

Fees

10. Make sure you include a check or money order for the proper amount of license fees and the non-refundable application fee.

Reciprocity

- 11. Please check with your state to determine if there is a Reciprocal Journeyman Electrician License Agreement between Oklahoma and the state in which you are currently licensed. A list of the states with which the CIB has a Reciprocity Agreement can be found on the CIB website (www.cib.ok.gov).
- 12. Reciprocal license can NOT be a 'grandfathered license'.
- 13. You must have had a license a minimum of one year to reciprocate.
- 14. The application including the 'Affidavit of Experience' and the 'Work History' must be completed.
- 15. If your address changes after you submit your application, notify CIB in writing. The Electrical Licensing Unit of the Construction Industries Board works very hard to process your application in a timely manner. Please do not call to check the status of your application. You will be notified in writing once your application has been reviewed.

EXAMINATION INFORMATION

All applicants are required to pass the Oklahoma electrical exam to gain licensure – exception: reciprocal applicants

Once the Construction Industries Board receives your application and remittance, it will be reviewed for approval. Your information will be forwarded to our national testing provider, PSI, for testing. You will receive notification from PSI on study material, testing sites, testing fees and testing dates. INSTRUCTIONS TO CERTIFIER VERIFYING EXAMINEE'S EXPERIENCE

The examinee named on this form is required to furnish one or more certificates in support of electrical construction experience shown on his/her application. The examinee, therefore, is requesting you to certify as to your knowledge of his/her experience per 158:40-5-3(g) "Each active electrical contractor shall document the hours worked by each apprentice electrician and the hours worked in commercial, industrial and residential electrical work."

All statements made on behalf of an examinee's experience in the classification cited on this form shall be verified by a qualified and responsible person, that is a licensed contractor who is the employer, or qualified representative of an electrical trade facility (Career Tech, IBEW, IEC, ABC, etc.), who has DIRECT KNOWLEDGE of the examinee's qualifications and capacity to become a licensed journeyman or contractor *(co-worker not applicable)*. The qualified and responsible person must certify that the examinee demonstrates a level of knowledge and skill expected of a journeyman or contractor in the classification for which application is being made.

The certifier must include actual hours worked while employed including, but not limited to, discussion of the examinee's knowledge of services and panel board installations, grounding applications, feeder and branch circuits, transformer installations, motor control applications, fixture installations and hazardous applications.

Your cooperation is earnestly solicited so that the Construction Industries Board can determine whether an applicant has the experience necessary to become a capable and qualified electrical contractor or journeyman electrician.

Any person who knowingly procures or offers any false or forged instrument to be filed, registered, or recorded in any public office, within this state, which instrument, if genuine, might be filed, or registered, or recorded under any law of the United States or of the law of the state (Title 21, Section 463), is guilty of a felony.
