## TEMPORARY JOURNEYMAN ELECTRICAL INFORMATION

Applicants must make application for Electrical exam within ten (10) days of beginning Temporary Electrical Journeyman work within the state. Verification is required of a current valid Electrical Journeyman License or equivalent from another state in which testing is a state requirement. Return Application and required fee to the address on the Application.

<u>Title 59 O.S. § 1685.1 Temporary Electrical Journeyman License in State of Emergency and OAR 158 Chapter 40 Electrical Industry Rules require the following:</u>

- A. Within one (1) year of the date the Governor of this state declares a state of emergency in response to a disaster involving the destruction of <u>dwelling units</u>, the Construction Industries Board shall issue a distinctively colored, nonrenewable, temporary Electrical journeyman license which shall expire one (1) year after the date of declaration to any person who is currently licensed as a Electrical journeyman by another state and who:
  - 1. Submits, within ten (10) days of beginning Electrical Journeyman work in this state, an application and \$25 fee for an Electrical Journeyman's examination;
  - 2. Takes and passes the examination at the first opportunity thereafter offered by the Board; and
  - **3.** Pays a temporary Electrical Journeyman's license fee of Fifty Dollars (\$50.00)

If you wish to have your successful completion of the Electrical Journeyman Examination under your Temporary Journeyman Application count towards an Oklahoma Electrical Journeyman License, please complete the regular Electrical Journeyman Application and submit with a \$25 application processing fee.

Title 59 O.S. § 1685.1 addresses the issuing of a Temporary Journeyman License. The Temporary Journeyman License is still subject to all other applicable laws of the State of Oklahoma and the Construction Industries Board.

Cost of temporary journeyman's license: \$25 Application Fee, \$50 License Fee, and \$92 PSI Testing Fee
