PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

KEY POINTS

- **3,631** cases were reported in the past week 15.0% decrease from the week before (Feb 28 Mar 6)
- **87** deaths were reported in the past week 47.9% decrease from the week before (Feb 28 Mar 6)
- 24,704 (5.7%) cases have been hospitalized
- 3,653,901 specimens have been tested in total
- 1,259,577 vaccine doses have been administered in total

The average age of cases was 41 years.

The youngest case was **less than a year old** and the oldest case was **100+ years**.

The average age of individuals who died was **75** years.

The youngest individual to die from COVID-19 was less than 15 years and the oldest was 100+ years.


























Distribution of recovered cases of COVID-19, March 2020 - March 2021, Oklahoma



Oklahoma State Syndromic Surveillance of COVID-19 related ED Visits August 30, 2020 – March 15, 2021







Cumulative incidence of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases









Cumulative death rate of reported COVID-19 cases in last 7 days



Weekly number of deaths (from all causes)


