PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.









JOHNS HOPKINS 7 DAY AVERAGE POSITIVITY RATE FOR SPECIMEN AND ANTIBODY CASES





COVID-19 VARIANT STRAINS

Genetic variants of SARS-CoV-2 have been emerging and circulating around the world throughout the COVID-19 pandemic.

• A variant has one or more mutations that differentiate it from other variants in circulation. As expected, multiple variants of SARS-CoV-2 have been documented in the <u>United States</u> and <u>globally</u> throughout this pandemic.

Three classes of variants:

- Variant of Interest
 - A variant with specific genetic markers that have been associated with changes to receptor binding, reduced neutralization by antibodies generated against previous infection or vaccination, reduced efficacy of treatments, potential diagnostic impact, or predicted increase in transmissibility or disease severity.
- Variant of Concern
 - A variant for which there is evidence of an increase in transmissibility, more severe disease (increased hospitalizations or deaths), significant reduction in neutralization by antibodies generated during previous infection or vaccination, reduced effectiveness of treatments or vaccines, or diagnostic detection failures.
- Variant of High Consequence
 - A variant of high consequence has clear evidence that prevention measures or medical countermeasures (MCMs) have significantly reduced effectiveness relative to previously circulating variants.











Distribution of recovered cases of COVID-19, March 2020 – May 2021, Oklahoma








Oklahoma State Syndromic Surveillance of COVID-19 related ED Visits August 30, 2020 – May 03, 2021




Cumulative incidence of reported COVID-19 cases



Total number of reported COVID-19 deaths



Cumulative death rate of reported COVID-19 cases











Cumulative death rate of reported COVID-19 cases in last 7 days



Weekly number of deaths (from all causes)


