Weekly Epidemiology and Surveillance Report January 16 - 22, 2022



PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

KEY POINTS

- **77,306** cases were reported in the last week, 7.8% increase from the week before (Jan 9-15).
- 171 deaths were reported in the past week.
- The cumulative crude case-fatality risk is 1.3%

WHAT'S NEW

This week's report includes highlights from recently released scientific publications.


The COVID-19 pandemic continues to be a fluid situation and our understanding of COVID-19 is constantly changing as the body of scientific knowledge grows.

The CDC routinely publishes scientific updates that summarize recent findings from a number of sources which can be found <u>here</u>.

- **39,950 (4.4%)** cases have been hospitalized. The cumulative hospitalization rate is **1009.6 per 100,000** persons.
- *119,050 specimens have been reported over the last 7 days according to the CDC COVID data tracker. * Counts reflect the tests reported since Jan 19.
- **4,540,719** vaccine doses have been administered in total

<u>RECENT FINDINGS</u>: COVID-19 CASES AND HOSPITALIZATIONS BY COVID-19 VACCINATION STATUS AND PREVIOUS COVID-19 DIAGNOSIS — CALIFORNIA AND NEW YORK, MAY—NOVEMBER 2021

"During May–November 2021, case and hospitalization rates were highest among persons who were unvaccinated without a previous diagnosis. Before Delta became the predominant variant in June, case rates were higher among persons who survived a previous infection than persons who were vaccinated alone. By early October, persons who survived a previous infection had lower case rates than persons who were vaccinated alone."


RECENT FINDINGS: PFIZER VACCINE BOOSTER AND MORTALITY DUE TO COVID-19

"Among adults aged ≥50 years, COVID-19 mortality was 90% lower among those who received a 3rd (booster) dose of BNT162b2 (Comirnaty, Pfizer/BioNTech) compared with those who received only 2 doses (adjusted hazard ratio [aHR] 0.10, 95% CI 0.07-0.14). Mortality was 0.16 per 100,000 persons/day in those receved a 3rd (booster) dose and 2.98 per 100,000 persons/day in those who did not."

This analysis was based on a review of electronic health record data for 843,208 adults over the age of 50 in Israel who were eligible for a 3rd dose and who had no prior history of SARS-CoV-2 Infection.










COVID-19 DAILY TESTS PERFORMED AND 7 DAY MEAN PERCENT POSITIVITY


Variant Proportions by Region, Dates of Specimen Collection: January 10, 2022 - January 19, 2022, (N=657; Omicron n=645, 98%):

Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2021 - January 26, 2022 (N=15,402)











Cumulative death rate of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases in last 7 days



Weekly number of deaths (from all causes)


