


















NEW CASES, HOSPITALIZATIONS, AND DEATHS BY AGE GROUP FOR WEEK OF MAY 8-14



Cumulative death rate of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases in last 7 days



Weekly number of deaths (from all causes)


