







Lineage Omicron - BA.4 Omicron - BA.5


Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - September 6, 2022 (N=12,350)




2022 CASES, PERCENT HOSPITALIZED, AVERAGE LENGTH OF STAY AND DEATHS BY AGE GROUP



Cumulative death rate of reported COVID-19 cases







Weekly number of deaths (from all causes)


