












COVID-19 VARIANT STRAINS SEQUENCED*

Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - September 27, 2022 (N=13,149)









Cumulative death rate of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases in last 7 days





Weekly number of deaths (from all causes)


