Personnel Updates:

Delaney Fitch's last day is September 23rd, 2022. This will leave us with two vacancies.

Closures:

1 restaurant and 3 pools closed due to imminent health hazards. The inspector assisted in finding a resolution and the facilities re-reopened when it was safe to do so.

Restaurants:

Various complaints were worked. All complaints were addressed with the management of the facility. The inspector assisted in finding a resolution to the complaint (if it was valid) and performed on site education when needed.

Dog Bite Investigations:

Various complaints were worked. In cooperation with the Cleveland County Sheriff's office, Norman Animal Welfare, Moore Animal Welfare, and Noble Police Department all bite incidences were resolved. Most of the bites were resolved by requiring the owner to quarantine the biting animal for a 10 day observation period following the bite incident. All animals were required to update the biting animal's rabies vaccination if necessary.

Truck Wrecks:

No truck wrecks were directly worked.

Enforcement:

No facilities in Cleveland County are currently on enforcement, with the exception of a few facilities for non-payment of license. We are continuing to work with management, corporate offices and owners of all licensed facilities to try to educate, mediate and correct violations so that the inspections do not result in further enforcement procedures.

SOONERSTART PROGRAM REPORT

SoonerStart Update:

- Program Update- In the month of June and July we had 80 referrals each, but in August we were back to normal with 67 referrals. We have been very busy trying to stay ahead of all of these referrals and getting everyone evaluated and on an IFSP as timely as possible. I attended the Interagency Coordinating Council meeting which is our governing body for SoonerStart, we discussed funding moving forward and that there are still a number of vacancies in SoonerStart across the state in both OSDH and OSDE. Jackie and I met with the other Regional Directors and Lead Clinicians from the entire state to discuss redistricting SoonerStart to correlate with Regional Director regions so after a transition period we will only have Cleveland Co. to oversee and provide serves to. We will continue to see our current clients in McClain and Garvin counties until they are able to hire more staff to handle the changes in their caseloads. We are preparing for our annual monitoring and making sure all of our data is current and correct,
- Staffing- Our Behavioral Health clinician had her baby August 17th so we are down two positions due to clinicians being out on maternity leave, and two vacant positions SLP and OT. But I am happy to announce that a Speech Pathologist has transferred from Oklahoma County EI to Norman she started August 29th and has picked up a number of clients already, and our SLP should be back from maternity leave at the end of this month. The Occupational Therapist position is going through the Workday process to be reposted in the new system.
- Early Foundations- Our Early Foundations program has moved to its new location at Bridgeview Methodist Church and is back up and running fully staffed and with a full caseload. We had two students transition to the Public-School program so we had two new students start in the last month.

Nursing Services Cleveland County Board of Health September 20, 2022

STAFFING: We have 1 new nurse at the Norman office. We still need 1 more RN to be fully staffed in Norman. We did have a resignation from the Moore office. We are fully staffed in Moore right now.

CLINICS: Have been steady. We do have some slower days, but stay busy for the most part

COMMUNICABLE DISEASE: The nurses in clinic are now investigating the monkeypox cases. Before the client would be worked up at OSDH and then OSDH would contact the CDN to do follow-up, but now the cases are automatically assigned to the nurses in clinic. We seem to see more people needing monkeypox vaccine in Norman than we do in Moore.

CHILD HEALTH: We still trying to get this up and running. We are reaching out to our partners as much as we can to get referrals, but it is a slow go.

COVID: With the new bivalent vaccine, we have seen an uptick of clients wanting the vaccine. Once again, more so in Norman than in Moore. We are still offering covid vaccine by appt in both Norman and Moore.



Local Emergency Preparedness Team

- We are schedule 9/30/22 for our Gap Analysis which will consist of OSDH-EPRS staff reviewing our Plans and Source documents and identifying gaps in preparedness for CDC Site Visit in 2023.
- o Monkey Pox Vaccine PODs
- Completed our Integrated Preparedness Planning Workshop (formally The Training
 Exercise Workshop) Had several community partners in attendance.
- Completed Our annual Stakeholders/Community Partner Briefing and Had 30+ community partners present. In the briefing we presented the new update Emergency Response Plans. These plans can be found here

- Hosted OSDH Emergency Preparedness HSEEP Training at the Well and had a full class.
- We hosted the Norman Monthly Public Safety Meeting at the Well and was so well received they asked if we could host it from now on.
- We had discussion with a few key public safety officials about hosting a Tabletop Exercise and discuss and exercise all response agencies roll in disaster response. This is a needed step for the agencies who are not normally included in day-to-day response but who may be called upon in large disasters. More info to come!!
- o Matt is a vital part in Research group At OU Center for faculty Excellence. They are doing a community need assessment over disaster response and other needs. The goal is to bring in key players like Norman and the County and VOADs like United Way to examine what capabilities we have in Cleveland Co and then work together as a community team to build those capabilities based on what we find. They are meeting with United Way and other Non- Profits Wednesday 9/21/22
- Brandon the District 10 Vaccine Specialist/mobile team coordinator, has seen an increase in uptake of COVID-19 vaccine since the Bivalent was released a few weeks ago.
- Working on getting mobile clinic vehicle hail damage repaired so we can get it wrapped and some flashy signage to hopefully draw more attention to our team when at events
- We had a First Aid/ Cooling Station at the Cleveland County Fair and had several staff members working an information booth as well.
