SUMMARY:

The proposed rule language incorporates changes made during the 2024 Legislative session. The rule change reflects HB3371 language which removes references to supportive home care assistants and amends language related to exemptions for unlicensed/uncertified personnel providing personal services. Changes include amending the frequency for on-site RN supervision from one to three months when certain competency and training requirements are met. The rule change also reflects HB3238 which amends certain definitions and carves out exemptions from Adult Day Care and Home Care Agency licensure for PACE programs as defined by 42 C.F.R Section 460.6. Proposed language also removes the requirement for home agencies to offer the flu vaccine onsite to employees.

PUBLIC HEARING:

Kerr Avenue, Oklahoma City, Oklahoma 73102 from 9:30 AM to 12:30 PM. The meeting may adjourn earlier if all attendees who signed up to comment have completed giving their comments. The alternate date and time in the event of an office closure due to inclement weather is December 5, 2024 in the Auditorium, from 9:30 AM to 12:30 PM. Those wishing to present oral comments should be present at that time to register to speak. The hearing will close at the conclusion of those registering to speak. Interested persons may attend for the purpose of submitting data, views or concerns, orally or in writing, about the rule proposal described and summarized in this Notice. Validated parking will be provided for the parking lot located at the east corner of Broadway and Robert S. Kerr Avenue, subject to availability.

REQUESTS FOR COMMENTS FROM BUSINESS ENTITIES:

Business entities affected by these proposed rules are requested to provide the agency with information, in dollar amounts if possible, on the increase in the level of direct costs such as fees, and indirect costs such as reporting, recordkeeping, equipment, construction, labor, professional services, revenue loss, or other costs expected to be incurred by a particular entity due to compliance with the proposed rule.
