## APPROVED COURSES

Qualifications for registration are a four-year baccalaureate degree with a major in public health, environmental health, environmental science, physical science, natural science, biological science, agricultural science or equivalent, from an accredited college or university with at least thirty (30) semester hours of work in physical, natural, and biological sciences, public health and/or environmental health.
