- 7. Sarah Connally shared a survey at Prehospital Pediatric Readiness Project website https://emspedsready.org/ needs to be completed by every EMS agency that responds to 911 calls before the end of this month. Currently Okla is at 39%; so, there is a lot of work still to be done. Contact Ms. Connally at 405.271.3307 ext. 2 or sarah-connally@ouhsc.edu for further information.
- 8. Dr. David Behm gave a presentation "Accuracy of Prehospital Trauma Priority Scores". Dr. Behm did a research project over Region 3's trauma priority score from January 1, 2017 through December 21, 2019. He reviewed EMS patient care reports to the emergency department reports. He compared Trauma Priority Score (TPS) and variables of age, gender, night vs day, EMS agency, licensure of medic, and mechanism of injury. When 2 or more comorbidities were present it affected the care/prognosis in the study. He reviewed 3,563 patient care reports, out of those 812 of the EMS patient care report did not have a trauma priority score, leaving only 2,751 charts that could be reviewed. The results of the study showed priority 2 was accurately recognized 37% of the time. The most common failure to account for was transient loss of concussion/altered mental status (48%), multiple comorbidities (40%), and orthopedic injuries. Priority 1 was accurately recognized 38% of the time. The most common failure to account for was sustained tachycardia (71%), central penetrating injury, and Glasgow Coma Scale (GCS) 13 or less. The summary of the research showed overall 59.5% of the patients were under triaged and 5.5% of the patients were over triaged. More than half (62%) were priority 1 patient that were inaccurately scored and under triaged.
