The meeting notice was filed with the Oklahoma Secretary of State on July 17th, 2020 at 1:26 pm. The meeting notice/agenda was posted on the Oklahoma State Department of Health website for the Region 3 RTAB on August 4th, 2020.

I. Call to Order

The meeting was called to order by Vice-Chair Dan McLeod at 10:31 am.

II. Roll Call

Roll call was taken with members present and absent reflected on the attached attendance sheet.

III. Introductions and Announcements

Dan McLeod thanked members for attending the meeting via Microsoft Teams. He requested members mute their microphone when not speaking, utilize the raise your hand feature and chat box for questions, and to state their name when casting votes.

IV. Approval of Minutes – February 20th, 2020

Dan McLeod announced a recommendation from the REPC was made to excuse absences for Harmon Memorial Hospital and Lawton Indian Hospital and that their absences at the February 20th, 2020 should be reflected as excused in these minutes. Rachel Talley noted that Alicia Webster had requested that Business Item E be changed to reflect the following: E. Discussion, consideration, possible action, and vote to recommend to the Oklahoma State Stroke System Advisory Council amendments to the Rural EMS Stroke Triage Algorithm Jennifer Woodrow requested members review the Rural EMS Stroke Triage Algorithm proposed by American Heart Association the Oklahoma State Stroke System Advisory Council and send any recommendations for improvement by email to her or Grace Pelley. A motion to approve the minutes with above changes was made by Johnston County EMS and seconded by Kirk's Emergency Service. There was no discussion and the motion was approved 10-0.



V. Reports

A. Emergency Systems Quarterly Activity Report - Jennifer Woodrow

Jennifer Woodrow noted staffing changes that included the addition of EMS Administrator Becky Novak and EMResource Administrator Anya Grether to the team. Marva Williamson is no longer with the Department, her position/Special Projects Coordinator is now open. The newest Trauma Fund handout was made available in the meeting packet for review. For Stroke Registry, the final list for the data dictionary has been completed and was presented at the July 15th Oklahoma State Stroke System Advisory Council meeting. The Trauma Referral Center (TReC) contractor assumed operations on March 1st, 2020 and TReC is now up and running. The Governor signed the proposed EMS rules which will go into effect on September 11th, 2020. EMS agencies needing a new unit inspections should use the following link to schedule the inspection: https://www.ok.gov/health/Protective Health/Emergency Systems/EMS Division/Ambulance Servi ces & EMRAs/Inspections/index.html. Martin Lansdale has transitioned roles and is no longer managing the Oklahoma EMS Information System (OKEMSIS); the Statistical Research Specialist position is currently being filled. Currently, no trainings are scheduled for either OKEMSIS or the Trauma Registry. EMS Director and the Oklahoma Trauma Education Programs (OTEP) training has been cancelled with hopes to rescheduled using a virtual format. If anyone is interested in attending the EMS Director training, please provide input on whether a full day or two half day classes are preferred.

- B. Oklahoma Trauma and Emergency Response Advisory Council Report Jennifer Woodrow The last meeting was canceled with the next meeting date currently tentative for October.
- C. Quality Improvement Committee Quarterly Activity Report Brandee Keele The Committee has not been able to meet since December but are scheduled to meet this quarter. The Committee is actively recruiting nurses as well as anyone else interested in serving as a member.
- D. Regional Education Planning Committee (REPC) Activity Report Brad Lancaster The Committee has been working on the Region 3 Board Rotation and Bylaw amendments that will be presented today for approval. The REPC voted to recommend approval of Option 1 of the Board Rotation with thming a working group to discuss further possible changes and options.
- E. EMS for Children Quarterly Activity Report Delores Welch No representative was available for report.
- F. Regional Medical Planning Group/Southwestern Medical Emergency Response Center Quarterly Activity Report – Robert Stewart The MCI and EMS Drills have temporarily been suspended and replaced with the COVID19 reporting data requirements. An RMRS awareness training is scheduled for August 14th. If EMResource or WebEOC is needed, agencies should send an email to get enrolled. EMS weekly COVID19 reporting started approximately 2 weeks ago. The next RMPG meeting is scheduled this day at 1:00 pm.

VI. Business

A. Discussion, consideration, possible action, and vote to approve EMResource two hour divert time recommendation

Jennifer Woodrow noted that Business Items A and B were discussed and voted on for approval at the last meeting. Due to motions being made by non-voting members, the items were not approved. A motion to approve a recommendation of an EMResource divert time of two hours was made by Southwestern Medical Center and seconded by Southern Oklahoma Ambulance Service. There was no discussion and the motion passed 11-0.

- B. Discussion, consideration, possible action, and vote to approve the following 2021 trauma system goals to send to the Regional Education Planning Committee for planning and implementation by October 2020
 - 1. Decrease the number of Priority 1 patients transported by ambulance services to a Level III or Level IV Trauma Center by 3% by the end of the calendar year
 - 2. Decrease the statewide average length of stay at Level III and Level IV Trauma Centers for patients having an ISS of ≥16 by 3% by the end of calendar year 2021

A motion to approve the above trauma system goals was made by Kirk's Emergency Service and seconded by Southwestern Medical Center. There was no discussion and the motion passed 13-0.

C. Discussion, consideration, possible action, and vote to approve attached amended Region 3 Bylaws

The proposed amended Region 3 Bylaws were presented to the Board with no discussion. A motion to approve the amendments was made by Johnston County EMS and seconded by Southern Oklahoma Ambulance Service. There was no discussion and the motion passed 13-0.



- D. Discussion, consideration, possible action, and vote to approve 2021 Board Member rotation Two options for a Board Member rotation with proposed 2021 Board Members for each were presented to the Board for review. Jennifer Woodrow gave a brief overview of both options stating that Option 1 met all guidelines voted on for approval at the July 17th, 2020 REPC meeting and set forth by the Region 3 Bylaws and the only difference between Option 1 and 2 was where the rotation began for rotating ground EMS members. Dan McLeod noted that the REPC moved to recommend Option 1 to the RTAB at today's meeting. A motion to approve the Option 1 Board Member rotation with associated proposed 2021 Board Members was made by Southern Oklahoma Ambulance Service and seconded by Mercy Hospital Ada. There was no discussion and the motion passed 12-0.
