## 5. Reports

- Tessa Cleary-Smith reports the Oklahoma State EMS Compact House Bill has passed and provides the website to look at information regarding the compact. A reminder is provided that in December the annual survey is due.
- Trauma:
  - A soft-launch OTEP was held with success. The OTERAC approved updated T3 algorithm is still waiting approval for disbursement.
  - Xana Howard shows a list of due dates that are included in the packet. All data through August 2023 is due. Trauma Registry training will be held November 7 and 8. OKEMSIS training will be on November 28. Hospital and EMS compliance reports are being handed out to please pass the information along. OERSSIRF application closed on October 7.
  - Rachel Talley reports the third quarter CQI meeting was held on July 17, 2023 with 5
    members present. 10 cases were reviewed and 17 letters authored. 3 letters required no
    response with 14 requiring responses.
  - Rachel Talley reports RPC was unable to meet due to quorum. Rachel reports that there is still work being done to work on the previously discussed breakdown of how Region 3 can improve working together to make a better trauma system for the patient.
- Robert Stuart reports MCI drill numbers need to be improved. Halloween Havoc drill will occur on October 31. 2023.
