5. Reports

- Lori Strider informed the committee that we are out doing unannounced inspections. EMS Vehicle inspections are still being scheduled online and conducted up by the State Capital. Trauma Registry compliance reports will be placed in BOX and there is upcoming training on how to use BOX. For OKEMSIS and Trauma Registry, those reports have to be submitted by 30 days after the previous month. Any questions over OKEMSIS, Trauma Fund, or Trauma Registry email Esystems@health.ok.gov and put your question in the email body.
- Dr. James Campbell shared with the group that the second quarter CQI meeting was held on April 10, 2024, via Microsoft Teams. There were eight members present. Five cases were reviewed by the group. There were 11 letters authored. One letter required no response, the remainder did require responses. One response was reviewed and accepted by the committee. The next scheduled meeting date is July 8, 2024, at 9:00 a.m. via Microsoft Teams. They are still having difficulty receiving requested records in a timely manner. Please ask your medical records departments to closely review those requests. He encouraged the group to respond to the letters if they received any and send in any cases in, they would like to be reviewed.
- Mark Forrest shared with the group that they met this morning at 10:00 a.m. The committee looks at time sensitive plans for the Region. Once the plan is completed, they vote on and then send them up to the RTAB's to vote on. Today the committee approved the STEMI plan and Envenomation plan. Mark encouraged everyone to attend the RPC meeting. Dr. Campbell shared with the committee some of the details for the STEMI plans and Sam Murray shared some details of the Envenomation plan.
- Sam Murray shared with the group that the eclipse came and went. They sent in an appropriate show of force for the request that was received. In the last Regional EMS team meeting they did adopt the S.A.L.T algorithm and will be updating regional plans to reflect the algorithm.

- 7. Sarah Connally shared with the group that they have their national EMS survey is out right now. If their agency has not received an email from us, please go to www.EMSpedsready.org to complete the survey. The survey is available every two years and does not take long to

Training is good but to be more proactive when it comes to the training. Having the right amount of equipment that would pertain to a mass casualty event is being worked out. Having the right equipment for the patients such as "tiny patients" older patients and children. We must practice more often to not become complacent.
