MINUTES

Meeting notice was also placed at the conference room at the Pittsburg County Health Department, 1400 East College, McAlester, Oklahoma 74501.

I. Call to Order

The meeting was called to order at 9:32 am by Acting Chair Brian Norton.

II. Welcome and Introductions
