### III. Roll Call

#### VI. Business

A. Discussion, consideration, possible action, and vote to amend the Stroke Plan Michelle Steele gave a report from the Oklahoma State Stroke Systems Advisory Committee. The level 3 Oklahoma Stroke Hospitals and level 4 thrombolytic administration algorithm were approved by OTERAC in February 2020 and are available for use. The tele stroke research list was included. This helps connect the smaller rural hospitals to the stroke plan.

The severity based stroke triage algorithm for rural EMS attached to Oklahoma State Stroke Systems Advisory Committee will be recommended to OTERAC at the next meeting. Currently Region 5 does not have a representative at OSCAR or OSSSAC quarterly meetings. Tammy Barnett was the representative for Region 5. It is recommended a new representative would be chosen.

- B. Discussion, consideration, possible action, and vote to discuss the results of the Trauma Plan destination survey
  - Mr. Henke shared that Rachel Franklin was sending a survey out to the EMS agencies in Region 5, but unknown if the survey was completed. Kari will assess the progress of the survey.
