# IV. Approval of Minutes – February 13th, 2020

The motion to approve the minutes from February 13th, 2020 was made by Delbert Gay and seconded by Darrell Spalding. There was no discussion and the motion passed 13-0.

# V. Reports/Updates

# A. Emergency Systems Quarterly Activity Report

Dean Henke provided the Emergency Systems report. He began with staffing updates that included the addition of our newest EMS Administrator, Becky Novak, and our EMResource Administrator, Anya Grether. The Governor has signed the proposed EMS rules, and they will go into effect on September 11th, 2020. Mr. Martin Lansdale has transitioned roles and is no longer managing the Oklahoma EMS Information System (OKEMSIS); a new OKEMSIS administrator is in the hiring process now. There currently is no training for OKEMSIS or the Trauma Registry. Please contact Dr. Yang Wan for trauma registry questions. The newest Trauma Fund handout is in the meeting packet; please review the submission dates to ensure that a deadline is not missed. Marva Williamson retired on July 31<sup>st</sup>2021. We are hoping to offer the EMS Director training in September and will most likely be a distance session. Please provide your feedback if you would prefer a 1 full day class or 2 half day classes. Likewise, our scheduled Oklahoma Trauma Education Program (OTEP) offerings may be transitioned into virtual classes. The final stroke registry data dictionary is completed and was presented to the Oklahoma State Stroke System Advisory Council (OSSSAC) at the July 15th meeting. The Trauma Referral Center (TReC) has had its new contractor assume operations on March 1st, 2020.

A motion was made to accept the addition of David Bruner to the REPC and Jeff Steinkamp to the CQI committee by Nate Toews and was seconded by Delbert Gay. There was no discussion and the motion passed 12-0.

 B. Discussion, consideration, possible action, and vote to excuse the absence for Pafford EMS Of Oklahoma (McAlester) on November 14<sup>th</sup>, 2019

Nate Toews asked why Pafford missed the November 14<sup>th</sup>, 2019 meeting and Mr. Henke shared it could have been an error. Delbert Gay said that Darrell Spalding is always at the meetings.

A motion was made to excuse the absence of Pafford EMS by Nate Toews and was seconded by Korey Langston. There was no further discussion and the motion passed 12-0 with Darrel Spalding abstaining.

C. Discussion, consideration, possible action, and vote to recommend to the Oklahoma State Stroke System Advisory Council amendments to the Rural EMS Stroke Triage Algorithm

Michelle Steele gave a report on behalf of the Oklahoma State Stroke Systems Advisory Committee. The level 3 Oklahoma Stroke Hospitals and level 4 thrombolytic administration algorithm were approved by OTERAC in February 2020 and are available for use. The tele stroke research list was included also. This helps connect the smaller rural hospitals to the stroke plan.

The severity based stroke triage algorithm for rural EMS attached to Oklahoma State Stroke Systems Advisory Committee will be recommended to OTERAC at the next meeting. Currently Region 5 does not have a representative at OSSSAC quarterly meetings. Tammy Barnett was the representative for Region 5. It is recommended a new representative would be chosen.

A motion was made to accept the stroke algorithms by Gerrick L. Johnson and seconded by James Smith. There was no further discussion and the motion passed 14-0.



- **D.** Discussion, consideration, possible action, and vote on Trauma Plan destination changes No action was taken.
- E. Discussion, consideration, possible action, and vote to approve the following 2021 trauma systems goals for implementation by the end of November 2020.
  - 1. Decrease the average length of stay in each trauma region at Level III and Level IV Trauma Centers for Priority 1 patients (ISS ≥16) by 3% by the end of Calendar Year 2021.
  - 2. Decrease the number of Priority 1 patients transported inappropriately to Level III and Level IV Trauma Centers by 3% by the end of calendar year 2021.

A motion was made to accept the 2021 Trauma System Goals by Amy Beckham and seconded by Delbert Gay. There was no further discussion and the motion passed 13-0.

F. Discussion, consideration, possible action, and vote to add the verbiage for excused absences in the Bylaws to (at the next scheduled meeting) Section VI. Attendance Expectations/Removal of Officers

An Officer is automatically removed from office if he/she misses one posted meeting or 25% of the scheduled meetings in any year without making arrangements for a proxy to attend or arranging for a unanimous vote by the RTAB. <u>Any member organization may request an excused absence from the Board (at the next scheduled meeting). It shall take a unanimous vote of the Board to overturn an absence.</u>

A motion to approve the excused absence verbiage was made by Delbert Gay and seconded by Nate Toews. There was no further discussion and the motion passed 13-0.
