I. Call to Order

The meeting was called to order by Chair Russell Martin at 1:00 pm.

II. Introductions and Announcement

Chair Martin announced to keep your devices muted unless you are speaking.



III. Roll Call

Roll call was taken with the following Board Members present: Broken Arrow Fire Department, Collinsville Fire Department, Creek County Emergency Ambulance Service, EMSA-East, Hillcrest Hospital South, Hillcrest Medical Center, Mercy Regional of Oklahoma, OSU Medical Center, Saint Francis Hospital, Saint Francis Hospital South, St John Broken Arrow, St John Medical Center, St John Owasso, and St John Sapulpa. Air EMS arrived at approximately 1:15 pm. The following Board Members were absent: Bailey Medical Center Owasso, Brookhaven Hospital, Owasso Fire Department, and Skiatook Fire and EMS. IV. Approval of the Minutes – January 21st, 2020

A motion to approve the minutes was made by Theresa Compos and seconded by K.C. Nickels. There was no discussion, and the motion passed 12-0.

V. Reports

A. Emergency Systems Quarterly Activity Report – Dean Henke

- Dean Henke provided the Emergency Systems report. He began with staffing changes that included the addition of our newest EMS Administrator, Becky Novak, and our EMResource Administrator, Anya Grether. The Governor has signed the proposed EMS rules, and they will go into effect on September 11th, 2020. Mr. Martin Lansdale has transitioned roles and is no longer managing the Oklahoma EMS Information System (OKEMSIS); a new OKEMSIS administrator is in the hiring process now. There currently are no trainings being offered for either OKEMSIS or the trauma registry, but please contact Dr. Yang Wan for trauma registry questions. The newest Trauma Fund handout is in the meeting packet; please review the submission dates to ensure that a deadline is not missed. Marva Williamson is retiring at the end of this month. We are hoping to offer the EMS Director training in September as scheduled, but it will most likely be a distance session. Likewise, our scheduled Oklahoma Trauma Education Program (OTEP) offerings may be transitioned into virtual classes. The final stroke registry data dictionary is completed and was presented to the Oklahoma State Stroke System Advisory Council (OSSSAC) at the July 15th meeting. The Trauma Referral Center (TReC) has had its new contractor assume operations on March 1st, 2020.
- B. Quality Improvement Committee Quarterly Activity Report Kari Smoot Kari Smoot discussed with group the CQI decision to vote on a letter of recommendation. It was also brought up that OTEP and T-3 response protocols were being violated by taking a patient to the wrong hospital initially that was not equipped to handle the patient. This is happening too frequently and that possible training at the EMS organizations needed to take place.
- C. Regional Educational Planning Committee Quarterly Activity Report Trudy Robinson Did not meet back in January 2020
- D. Regional Medical Response System Quarterly Activity Report Amy Wenham Amy Wenham shared staffing updates. Bobby Benn is the new Director and James Plumlee is no longer with the RMRS. The pediatric surge plan is still being reviewed.



EMResource has been used significantly to obtain reports from the hospitals and then shared with Governor Stitt.

Mr. Henke shared the breakdown of 2021-2022 rotation which was used with some of the proposed changes to the Region 7 Bylaw being worked on by the Regional Planning Committee.

Mr. Henke shared the attendance for the RPC for 2019-2020. There were two members who have not responded since January 2019. The new list of committee members should provide a better opportunity to reach quorum.

- E. Discussion, consideration, possible action, and vote to approve the following 2021 trauma system goals for planning and implementation by October 2020
 - 1. Decrease the number of Priority 1 patients transported by ambulance services to a Level III or Level IV Trauma Center by 3% by the end of the calendar year
 - 2. Decrease the statewide average length of stay at Level III and Level IV Trauma Centers for patients having an ISS of ≥16 by 3% by the end of calendar year 2021

Mary Howell asked what the current length of stay. Dan Whipple provided that with the Covid and staffing changes we have not been able to get the latest data. Mr. Whipple provided the data presented back in January 2020. The average length of stay for Level III and Level IV hospitals was 191 minutes. This is for patients with an ISS of \geq 16. Ms. Howell asked the number of Priority 1 patients transported to a Level III or Level IV facility. Mr. Whipple shared that there were 66 Priority 1 patients from within the Tulsa Region transported to a Level III or Level III or Level IV facility.



A motion was made to approve the 2021 Trauma System goals by Mary Howell, and was seconded by Kari Smoot. There was no further discussion and the vote passed 14-0.

VII. New Business (for matters not reasonably anticipated 48 hours prior to the meeting)

Chair Russell Martin shared with the Board his desire to start an Ad Hoc group to clean up the Bylaws and present them to the RTAB at the 4th quarter meeting. He has contacted Mary Howell, Kari Smoot, and will reach out to James Annas Jr. A motion to start the Ad Hoc group was made by Theresa Compos, and seconded by Stacie Boyd. There was no further discussion and the motion passed 13-0.
