MINUTES


- L Meeting called to order at 1:11 p.m.
- 11. Roll called with attendance reflected in attached documentation.
- III. No introductions or announcements.
- Approval of Minutes (July 12, 2022)......David Howerton, Chair IV. Motion made to approve minutes from July 12, 2022 and passed without discussion.

V.

- Chris Dew introduces Tessa Cleary-Smith as new EMS Administrator. Current vacancies include an EMS Administrator, Epidemiologist and Statistical Research Specialist. Regulatory inspections continue and EMS services should expect unannounced inspections. Key focus this year has been medical direction involvement in EMS agencies. Oklahoma Trauma Education Program training is October 26, 2022 at the Oklahoma City Oklahoma Department of Transportation Training Center from 9:00 a.m. to 11:00 a.m. Trauma registry requires data to be entered by hospitals and data must be entered by the last weekday of the month, of the month following when care was rendered. Trauma Fund deadlines are including in the handout. Oklahoma Emergency Response Systems Stabilization and Improvement Revolving Fund reviews were completed October 6 and were published yesterday, October 10, 2022.
- Oklahoma Trauma and Emergency Response Advisory Council.........David Howerton, Chair OTERAC met October 5, 2022 and removed OAC 310:645 and added OAC 310:643. OTERAC discussed having American College of Surgeons review the state of Oklahoma Trauma System. Four OTERAC meeting dates were approved alternating between Tulsa and Oklahoma City.
- Continuous Quality Improvement Committee......David Gooshaw, Committee Vice Chair The committee met on October 3, 2022 via Teams. Nine cases were reviewed with eight cases having letters authored for response. Three cases were closed. Five responses were received that did not require further action. The next meeting will be January 10, 2023 and will be an in-person meeting. Committee requested documentation of trauma triage for prehospital and hospital.
- Hospitals are currently contributing what they are able to in a trauma rotation and are meeting soon to see which facilities can continue to participate in support and monitor timely response by providers.
- Regional Planning Committee......Brad Smith, PA, Committee Chair Met this morning and verbiage was approved for the burn language.

VI. Business

- B. Discussion, consideration, possible action and vote to approve possible recommendations regarding divert of the unassigned Priority 2 hand, OMFS, and neurosurgical trauma patients while scheduled as the Region 8 Trauma Rotation on call facility...... David Howerton, Chair Reported no vote needed. OU presented their trauma divert times over the last four years which revealed a total of 10.5 hours of divert time which equals around 2.6 hours of trauma divert a year. Administration has put in to motion that divert will only be issued if there is a disaster in which OU will contact the Medical Emergency Response Center to assist with the divert and disaster.
