

- Medical Facilities Director. Dr. Hockmeyer introduced himself and shared he comes from the hospital world as President/CEO of Ascension St John – Owasso and is looking forward to meeting everyone. EMS initial vehicle inspections are scheduled online, and agency inspections are being conducted yearly. Renewal season ended on June 30, 2024, but medic's and agencies have a grace period until July 31, 2024. If you have not submitted your renewal forms, your license will be expired, and an initial application must be submitted. Trauma Fund, Trauma Registry, OKEMSIS, and EMResource questions should be submitted to Esystems@health.ok.gov and put your questions in the body.
- Region 6 & 8 Quality Improvement Committee
   David Gooshaw reported they reviewed seven cases with 6 feedback letters generated.

   Response letters were sent out in April and the committee is waiting for letters to be returned.
- Trauma Rotation Committee (TRC) Dr. David Smith reported the committee met as scheduled. They discussed the TRC itself and appointed two members. Dr. Smith shared there were concerns about TReC expiring and the TRC drafted a letter to OSDH and the Commissioner of Health to review the situation. Hand Call was discussed and reported the Hand Call schedule is posted yearly. TRC bylaw verbiage was reviewed and showed the TRC can call special meetings. The TRC is expected to meet irregularly at this point depending on the subject matter that needs addressing.
- Regional Planning Committee
   Interim Chair David Howerton reported that Chair Brad Smith was not present at the
   meeting, but Larry Terry presided until Mr. Howerton arrived. Mr. Terry reported about being
   able to call a special meeting being in the Region 8 bylaws and will be placed on the next RPC
   agenda. Mr. Terry shared the committee is very close to finalizing the Region 8 Trauma Plan
   edits and should be completed at the 4<sup>th</sup> quarter meeting. Mr. Henke reported to the RTAB
   Chair that verbiage was found in the Region 8 bylaws that the RPC can call a special meeting.
- Regional Medical Response System No report was given
- Region 8 Prehospital Trauma Transports Data Report Maxine Council the data is running consistent with 140-150 trauma calls per month. Priority I calls were very small with Priority II calls being higher, but Priority III calls were significantly higher. Head injuries lead the P-I patients, one burn patient transported to INTEGRIS Baptist, and one pediatric patient transported to OU Childrens with the remaining P-I patients transported to OU Medical Center. One error was reported a P-I patient was transported to SSM Midwest but is being corrected to OU Medical Center. Chief Carl Cobb reported the City of OKC Fire/EMS started transporting in June with 91 trauma patients with 8 P-I patients with head injuries being most common. All P-I patients were transported to OU Medical Center. Mr. Howerton reported that 63 units of whole blood have been administered since October 2022. There is an 83% success rate of whole blood being administered. Mr. Howerton reported that Region 7 is now administering whole blood.



  - 1. Protocol utilized to determine the trauma rotation schedule for hand injuries. No new verbiage will be added to the Region 8 Trauma Plan.
  - 2. Roles and responsibilities of stand-alone emergency rooms within the trauma system to include expected participation in trauma communication tool. Dr. Smith reminded the board that previous discussions were that the Stand Alone Emergency Rooms (SAER) were welcome to attend the Region 8 RTAB meetings and to participate on EMResource stating their capability and capacity. Mr. Howerton asked if the SAER can be put on EMResource. Michelle Faulkner said SSM would do the training for all SSM SAER. Dr. Hockmeyer will find out if there is a charge to add a SAER to EMResource. Mr. Howerton suggested putting the SAER into the EMResource system.

Sarah Komes shared the call volume was triple what was expected but things have gotten better. AMR is also facilitating transports to Okla City better.


