INSTRUCTIONS FOR USE OF THE AFFIDAVIT OF LAWFUL PRESENCE BY GUARDIAN OF PERSON MAKING APPLICATION FOR A LICENSE, PERMIT OR CERTIFICATE

The person signing this form must read these instructions carefully.

- 1. If the person executing this form is receiving services and not making an application for a license, permit or certificate, this form should **not** be used but rather, either the form titled, "Affidavit of Lawful Presence by Parent or Guardian of Person Receiving Services" or the form titled "Affidavit of Lawful Presence by Person Receiving Services" should be used.
- 2. If the person executing this form is under the supervision of a guardian or other person invested with the power to manage his or her rights or appears unable to understand the nature and consequences of his or her acts as they relate to the application for a license, permit or certification provided by the Department, this form should be used, and the guardian or person invested with the authority to manage the rights of the person making application should execute it on behalf of the person making application in accordance with that person's legal status in the United States. If the person making application is not under the supervision of a guardian or other person invested with the power to manage his or her rights or appears able to understand the nature and consequences of his or her acts as they relate to making application for a license, permit or certification provided by the Department, this form should *not* be used but rather, the form titled, "Affidavit of Lawful Presence by Person Making Application for a License, Permit or Certificate" should be used.
- 3. If the person making application is a citizen of the United States, then the person executing this form on behalf of the person making application should check the box to the left of the statement, "The person making application states he/she is a United States citizen." If the person making application is not a citizen of the United States but is an approved alien under the federal Immigration and Nationality Act and is approved to be present in the United States, then the person executing this form on behalf of the person making application should check the box to the left of the statement, "The person making application states he/she is an approved alien under the federal Immigration and Nationality Act and is approved to be present in the United States."
- 4. Provide the identification number in the space provided after "Admission/Registration #" and check the box to the left of the authorizing document type. Print applicant's name in the space after "Print name of person applying for license, permit, or certificate."
- 5. In the space after the word "Date" the person executing this form should write today's date. The person executing this form should indicate the city and state where they are actually located when they sign this form in the space provided for signature and print name in space provided. If applying for a renewal, write the license, permit, or certificate number in the space provided.
- 6. Within the context of the execution of this form, the term "penalty of perjury" means the willful assertion of the fact of either United States citizenship or lawful presence in the United States as a qualified alien, and made upon one's oath or affirmation and knowing such assertion to be false. Making such a willful assertion on this form knowing it to be false is a crime in Oklahoma and may be punishable by a term of incarceration of not more than five (5) years in prison. Additionally, one who procures another to commit perjury is guilty of the crime of subornation of perjury and may be punished in the same manner, as he would be if personally guilty of the perjury so procured.
