Resident rights - Each assisted living center and its staff shall be familiar with and shall observe all resident rights and responsibilities enumerated under Title 63 O.S. Section 1-1918(B). • Title 63 O.S. Section 1-1918(B)(5) Every resident shall have the right to receive adequate and appropriate medical care consistent with established and recognized medical practice standards within the community. • 310:663-19-1(b)(10) reportable diseases and injuries as specified by the Department in OAC 310:515 (relating to communicable disease and injury reporting). • Adult Day Care: 310:605-13-1(6)(J) Any participant who shows symptoms of illness or infectious disease shall be given the necessary attention and/or removed from the group. • 310:605-11-1(5) Staff who have direct contact with participants shall be free of communicable disease. • Residential Care: 310:680-3-6(c) Reports of communicable disease shall be made in accordance with the adopted requirements of the Board of Health. <p style="text-align: center;">CDC provides guidance on the Standard of Care for COVID-19.</p>
<p>Definitions</p>	<p>Healthcare settings - refers to places where healthcare is delivered and includes, but is not limited to, acute care facilities, long term acute care facilities, inpatient rehabilitation facilities, nursing homes and assisted living facilities, home healthcare, vehicles where healthcare is delivered (e.g., mobile clinics), and outpatient facilities, such as dialysis centers, physician offices, and others.
