

Hospice and Home Health COVID-19 Call 07/09/2020

- 1. Welcome
- 2. The all-time most asked question continues to be, "When do I have to renew my license to operate a home care or hospice?
 - a. 14 days after EO has ended
 - b. Please feel free to do so now
 - c. For information regarding the Home Care Administrator License please contact Nurse Aide Registry at NAR@health.ok.gov.
- 3. The next most asked question is related to current TB requirements
 - a. State regulations (661. 662 and 667) are in the process of revision
 - b. Changes will incorporate 2019 CDC guidelines
 - c. We originally expected to see this in writing around the 3rd quarter of this year
 - d. The rules will be published in the September 1 edition of the OK Register and will be effective on September 11.
 - e. In anticipation of the change, what are you doing as a home health or hospice?
 - 1. Have you revised your policies and procedures?
 - 2. Are you following your policies and procedures?
 - 3. Does your policies and procedures continue to require annual testing?
 - 4. You can choose to be more stringent.
 - 5. Where you chose to be more stringent, we hold you to that requirement.
 - 6. Some callers state they will not make changes until they see documented changes in the 662. That is OK.
- 4. Questions regarding COVID 19 testing:
 - a. If we were in contact with someone who tested positive or was in contact with someone in contact with someone who tested positive, what should we do?
 - 1. Call 211
 - 2. or 877-215-8336 to speak with a specialist or on-call epidemiologist.
 - b. Self-isolate as instructed
 - c. Get tested as instructed
- 5. We are concerned that employees will claim contact with a potentially infected person in order to get paid time off from work. How do we handle that?



- a. Have you made updates to your personnel policies based on these concerns?
- b. Have you made updates to your emergency preparedness and infection control policies?
- c. Have you re-updated based on new increases in infection rates?
- d. Have you had employees sign notification of changes for any agency changes in policy/procedures/leave/paid-time-off policies?
- 6. (segue from previous question) With increases in COVID-19, has your agency made changes in your infection control practices? What changes have you made to keep your staff and clientele safe?
 - a. Have you stepped back to a previous phase?
 - b. Do you require PPE with every patient encounter?
 - c. What are your practices in the office environment for office staff? Is this different for field staff?
 - d. Are you modeling the practices that you expect your staff to follow? (i.e. are you practicing social distancing in the office, during meetings and gatherings?)
 - e. How can you ensure your staff knows the most current IC policies/practices of your agency?
- 7. Survey activities
 - a. We continue to participate in infection control related surveys that rise to the IJ and non IJ level
 - b. Agencies with past issues in non-compliance in infection control, abuse, neglect wounds, etc. may be identified as needing attention as well
 - c. CMS guidance provided for non-long-term care survey expectations has been grey with hints of return to regular survey activities.
