District Court grants oral motion of the parties to consolidate pending actions and issues *Order Granting Motion to Remand*, to address statutorily required findings of fact consistent with 63 O.S. § 1-853(A), 04/23/2010. Department filed with the Court a revised *Order* granting certificate of need on 05/06/2010. Judge Robertson held a scheduling conference 06/30/2010, and issued an order establishing the briefing schedule. On 8/4/2010, the court issued an ordering allowing an extension of 30 days for petitioners to file briefs. On 9/15/2010, intervener Autumn Wood and the Department separately filed responses to the petitioners. On 9/27/2010, petitioners filed reply briefs to the responses of the Department and Autumn Wood.
