 - A. Use of Propofal for interfacility transfers (Dr. Cathey)

Pros and cons of approving use of Propofal discussed. Interfacility formularies and protocols discussed.

It was generally agreed that it is within the scope of practice for a paramedic to continue a Propofal drip during an interfacility transfer with the correct caveats included in the protocol request. Automatic reviews of low frequency, high risk treatments would protect the Medical Directors, the agencies, and the public.

B. Update on EMS Drug Shortage (Dr. Cathey)

The drug shortage issue is expected to be a problem for the foreseeable future.

C. OUHSC EMS Protocol Discussion and Review (Dr. Cathey)

The protocol set will be ready for review no later than the morning of June 11 so that the Medical Direction Subcommittee has a full week to review the protocols before the meeting on June 18.

The June 18 meeting will begin at 8:30AM and the protocols will be reviewed and discussed. The August 15 meeting will be for final discussion and approval of the protocols.

July 1, 2012 through July 31, 2012 will be the public comment period.

During the August 15 meeting, public comments already received will be reviewed and new public comments will be welcomed. The August 15 meeting will be scheduled from 1PM to 5PM.

Protocols will be sent to the EMS Agencies and Medical Directors for public comment.
