8. Discussion

- a. Changing, combining or dissolving the palliative care working groups- Dr. Hendrix gave reasons to dissolve current palliative care working group. There is a desire to form a new group who will provide a more concrete definition of Palliative Care. There have been six people identified who want to work on this. The older group will not continue to meet.

- d. SB388-Karen asked for update on who could suggest language. Dawn asked what language the group wanted. Dr. Frazier stated that anyone can write rules and present to OSDH for consideration. She also encouraged consideration of Senate Bill not too become too restrictive to prevent constant rewriting of bill. Karen asked about a timeframe and Dr. Frazier said that an update would be expected by spring.
- e. Building/maintaining the CNA workforce-No comment

- f. Reducing the number of CNAs working in home care who are not under the auspices of a licensed agency-No Comment
- g. EMT/Paramedics in home care and community based care-Jan is on the Board of EMSA and she stated that paramedics want to go into home health to allow them opportunity for career advancement.
- h. Consideration of flu vaccine in current home health rule to be given "on site"-Karen asked for expanded definition of "on site"; specifically, could an agency that sent staff off-site to get flu shots be cited? Dr. Frazier said it was possible but there was not a blanket yes or no. Dr. Frazier stated the larger issue was when an agency was unable to provide a program plan of how they ensure compliance.
- i. Interpretation of home health agency requirements for self-reporting complaints/incidents to OSDH and reporting vital signs outside parameters to physician when problem is resolved with current orders- Karen asked for interpretation of HHA agency regulations. Dawn recommended ensuring a clear care plan for those policies and procedures. Dr. Frazier stated that a Plan of Care should be individualized to potentially address those concerns.
