Definitions: The Unemployment Rate estimates the percent of an area's civilian work force (age 16 and over) that is unemployed. To be counted as unemployed an individual must be out of work, currently available for work and actively looking for work. The annual unemployment rate is an average of an area's monthly rates. Rates reported here are three-year annual averages for each area.

Data Source: Unemployment Rate data uses U.S. Bureau of Labor Statistics for the referenced years.

Footnotes: Unemployment Rates are frequently criticized as being too low as a result of not counting unemployed workers who have abandoned their efforts to find employment (discouraged workers). Unemployment rates are also very volatile during any economic downturn. For example, Oklahoma's unemployment rate for most of 2010 was higher than the latest three-year period (2007-2009) reported. Regardless, the three-year average unemployment rates used in KIDS COUNT

Fact books provide a reliable and valid basis of comparison of unemployment among Oklahoma counties and the state. The unemployment rate is typically the best measure of people's ability to improve economic conditions through work. When subsequent government reports adjust and update unemployment rates which had been reported earlier, the revised figures are used to calculate subsequent annual averages in KIDS COUNT Factbooks.

Definitions: The number of children living in poverty counts related children under the age of 18 who live in families with incomes below the U.S. poverty threshold. The percent of children living in poverty compares the number of children living in poverty to children who live in families with any amount of income. Related children are the children related to the "family head" by birth, marriage or adoption and include relatives such as nieces and nephews. Children under age 18 who do not live in a household where they are related to the head of the household are not included in this analysis. Data counts only families for whom an income level has been determined. Updated annually using the Consumer Price Index, the poverty thresholds, as defined by the U.S. Bureau of the Census, are based upon the amount of money required to purchase a nutritionally adequate diet. A family is classified as poor if its income falls below this minimum standard. For example, in 2005, a single adult (under age 65) with one child would be counted as poor if their income fell below \$1,122/month; with two children below \$1,311/month; with three children below \$1,656; and so on.

Data Source: Data uses the U.S. Bureau of the Census, Census of the Population and Housing 1980, Summary Tape File 3A, U.S. Bureau of the Census, Census of the Population and Housing 1990, Summary Tape File 3A and U.S. Bureau of the Census, Census of the Population and Housing 2000, Summary Tape File 3.

Definitions: The number of children living in poverty estimates related children under the age of 18 who live in families with incomes below the U.S. poverty threshold. The percent of children living in poverty compares the estimate of children living in poverty to an estimate of children who live in families with any amount of income. Related children are the children related to the "family head" by birth, marriage or adoption and include relatives such as nieces and nephews. Children under age 18 who do not live in a household where they are related to the head of the household are not included in this analysis. Data estimates only families for whom an income level has been determined. The poverty thresholds, as defined by the U.S. Bureau of the Census, are updated annually based on many factors. A family is classified as poor if its income falls below this minimum standard. For example, in 2010, a household of two would be counted as poor if their income fell below \$14,973/year; a household of three below \$17,568/year; or a household of four below \$22,113/year; and so on.

Data Source: Data from the U.S. Bureau of the Census, Small Area Income and Poverty Estimates (SAIPE), for each year.

Footnotes: Child poverty rates are typically the best measure of the presence of very poor children in a community. These estimates combine data from administrative records, intercensal population estimates, and the decennial census with direct estimates from the American Community Survey to provide consistent and reliable single-year estimates. These model-based single-year estimates are more reflective of current conditions than multi-year survey estimates.

Definitions: The share of children under age 18 who live in families with incomes below the federal poverty level.

Percent by race is equal to the percent of each population living in poverty. Example: 16% of White children living in poverty in Alfalfa county means 16% of the White children in Alfalfa county are in poverty, not that 16% of all children in poverty in Alfalfa are White.

The federal poverty definition consists of a series of thresholds based on family size and composition. In calendar year 2015, a family of two adults and two children fell in the “poverty” category if their annual income fell below \$24,036. Poverty status is not determined for people in military barracks, institutional quarters, or for unrelated individuals under age 15 (such as foster children). The data are based on income received in the 12 months prior to the survey.

This number is then divided by itself plus the graduate count from the selected year to derive the rate. Public school officials are required to notify the State Department of Education (OSDE) of the name, address, race and age of any pupil dropping out of school. (Required by state law, Title 70, Okla. Supp. 2005 § 35 e (A)). Beginning with the Class of 2017, the dropout rate is calculated using all high school dropouts; prior year's data was calculated for dropouts under 19 years of age.

Child Abuse and Neglect means harm or threatened harm to a child's health or welfare by a person responsible for the child's health or welfare. Several changes made to Oklahoma's Child Abuse Statutes during the 2007 Legislature were in effect during the time periods for which data was collected. The following definitions follow the law in effect during the period covered by the DATA CENTER. Child Abuse includes sexual abuse, sexual exploitation or non-accidental physical or mental injury. Abuse can also include harm resulting from failing to protect or abandoning a child. Sexual Abuse includes rape, incest and lewd or indecent acts or proposals by a person responsible for the child's welfare. Sexual Exploitation includes a person responsible for the child's welfare allowing or encouraging a child to engage in prostitution or pornography or engaging in child pornography. Neglect means failing to provide adequate food, clothing, shelter, and supervision; failing to provide special care made necessary by the physical or mental condition of the child; or abandonment. *Title 10 Okl. St. Ann. 2006 § 7102*. Data includes reports of suspected abuse or neglect containing allegations of serious or immediate threats to a child's safety for which there were formal investigations and, of those, the number for which abuse or neglect was confirmed. Rate means the number for which abuse or neglect was confirmed per every 1,000 children in the geographic location.
