6. Update: Enforcement and Quality Review-Administrative Programs Manager

Lee Martin reported Vonnie Meritt retired from state service in December 2014. The Department will be interviewing for an HAI Coordinator position in the near future. The department will also be interviewing for an Administrative Programs Manager position soon. The department has hired a new enforcement analyst that will be working with the hospitals. There are currently two architect positions open in the Health Facilities Plan Review Division.

The Department will be beginning a Quality Improvement project in conjunction with the Oklahoma Hospital Association. The agency is projecting this project will take approximately 6 months. This group will be looking at current department processes and looking at ways to improve these processes.

7. Update: Good Samaritan Workgroup meeting Held on January 8, 2015

Enrolled House Bill 1641: Amending 63 O.S. 2011, Section 1-502.1

Dr. Heather Bell reported the working group met in Tulsa to discuss the act that was passed and how they can develop the framework on January 8, 2015. The group has identified several obstacles and road blocks. They have identified the need for a health care lawyer and a representative from the Oklahoma State Department of Health should be included in these discussions. As soon as a Healthcare lawyer is identified and a representative from OSDH has been identified, then another meeting will be scheduled for this group.

8. Update: Hospital Advisory Council Workgroup scheduled for Tuesday, March 10, 2015 at 3:00 p.m. in Room 806 of the OSDH, 1000 NE 10th Street, Oklahoma City, OK 73117-1299

Lee Martin reported for Dr. Cathey the workgroup will be working to get a consensus in standardizing the protocol for EMS inter-facility protocol for the transfer of acute care patients and development of triage guidelines to early identify the patients who would benefit the most from early stabilization and early transfer to the comprehensive stroke center.

9. Public Comment

There was a comment on the upcoming stroke legislation and that there was a lot of opposition to the stroke classification. There was a brief discussion about the issues currently ongoing in hospitals relating to Good Samaritan bill. Discussion about who is responsible for reporting exposure occurring at an accident site. A comment was made that it would be difficult to get over 100 hospitals to follow the same protocol. Further discussions about hospitals reporting of current infectious diseases are already reporting to the State Health Department.
