- III. INTRODUCTIONS AND ANNOUNCEMENTS: Richie Bohach had everyone introduce themselves and who they represent.
- IV. APPROVAL OF MINUTES: Minutes presented October 25, 2016. Motion to approve minutes made by Brad Lancaster and seconded by Bob Stewart. Minutes were approved by the four members present.
- V. BUSINESS:
 - 1. Scott Tanner discussed using the first three sections from the Region 5 Stroke plan as recommended from the last meeting. Section four was brought over and replaced with Region 3 facilities. Region 5 is only going out to seven hours and this is recommended up to eight hours for retrieval. Scott asked for input on how the region would like to address the issue of time restraints for Priority two patients and how the region would look at getting these patients to a Level One or Level Two Stroke Center. It was recommended that the region look at adding this later in an appendix once the system is running. Dan recommended that OTERAC will probably recommend adding something about flying patients to a Level One or Level Two Stroke Center. It was recommended to look at use of Air services on time lines not distance lines like the region has in the trauma plan. Dan Whipple discussed the DAWN trial looking at extending the times for clot removal for strokes.
 - 2. Richie Bohach discussed the pre-hospital working group. Brought over number one from region 5. 'Basically using region 5's information updating the information for region 3 on most of the plan. Making an appendix of section 6 in the regional plan. All appendix information would be in section 6. The way the region address QA/QI section initially is each agency and facility develop their own stroke plan that is constant with this plan but not limited to this plan. CQI process be part of this plan. Closest facility does not have to be in this region. QA component does not have to be in the plan at this time per Dan Whipple.
