- V. Business:
  - A. Region 3 Trauma plan was reviewed by committee for updates. Items that were reviewed are as follows:
    - Looked at updating the hospital levels for region 3. Region 3 has five (5) level III facilities and fourteen (14) level IV facilities of which nine (9) are designated critical access.
    - 2. Looked at changing verbiage on EMResource dealing with air being live and what the colors mean.
    - 3. Addressed facility name changes and levels
    - 4. Addressed adding Medical City Denton to trauma plan they are a level II trauma facility.
    - 5. The committee is forming a working group to look at trauma destination plans for the region with changes in agencies and facilities.
    - 6. The committee reviewed and eliminated the facilities and agencies that are no longer in the region.
    - 7. The working group is looking at if changes need to be made for ALS intercept in the trauma plan.

- 4. Duty of officers states the chair will appoint all committee chairs. Committee agreed that since it is mentioned under Standing Committee's that the committee will select the chair of the committee and it be removed from the RTAB chairs duties and remain under Standing Committees.
- 5. CQI leave as is for now.
- C. Discussion on the 2018 Stroke Guidelines Alicia Webster stated that OSSSAC is working on a stroke algorithm for level III and Level IV stroke centers. This committee meets on July 18<sup>th</sup> and they will take the algorithm to the physicians meeting to get their approval before we bring it before the RTAB. It was stated this was a good idea because stroke treatment is advancing so rapidly. Stroke patients still need to be transported to facilities that can perform CTA scans. It was also brought up that the stroke plan should contain verbiage that contains the facilities that do administer TPA. It was discussed that the latest information to come out is TPA needs to be started in 4.5 hours of last know well, but 24 hours for large vessel occlusion candidates.
- D. The committee decided to have the trauma plan and bylaws sent out to them for review and recommend changes to before the next RTAB on August 2<sup>nd</sup>.
