MINUTES

I. Call to Order

The meeting was called to order by Chair Chelsea Bishop at 10:30 a.m.

II. Roll Call

Roll call attendance was taken with the following Board Member absent: Pafford EMS of Latimer County. The following General Members were absent: Air Evac 129, Air Evac 139, Air Evac 22, Air Evac 65, Air Evac 67, Air Evac 73, Creek Nation Community Hospital, Eastern Bryan County EMS, Hartshorne Ambulance Service, Holdenville General Hospital, McAlester Fire Department/EMS and Wewoka Fire Department. It was brought to the attention of the Board that Clayton EMS, Weleetka-Graham EMS and Lane Frost Health & Rehab Center were no longer licensed. Ms. Bishop recommended the State check licenses to update attendance.

III. Introductions and Announcements

No introductions or announcements were made.

IV. Approval of Minutes – November 10th, 2016

A motion to approve the minutes was made by Delbert Gay (Antlers FD) and seconded by Kim Ross (International Paper). The motion passed unanimously after a roll call vote.

V. Reports

A. Emergency Systems Report

Dan Whipple delivered the Emergency Systems report. Emergency Systems is fully staffed hiring 3 additional personnel. Names and introductions of new Emergency Systems personnel were presented to the Board. The quarterly Emergency System report will now be presented as an annual report at the 4th quarter meetings. Trauma Registry questions or training needs were directed to call Dr. Kenneth Stewart. Martin Lansdale will be at Kiamichi Tech on April 13, 2017 from 10 to 6 to teach OKEMIS training to EMS agencies along with report writer. Reminder of new EMS rules that went into effect on September 11, 2016. Reminder of Naloxone training provided through the Health Department. The next Oklahoma Trauma and Emergency Response Advisory Council (OTERAC) meeting will be March 1, 2017 at 1:00 p.m. at the Oklahoma State Department of Health.

B. Regional Sub-Committee Report

1. Continuous Quality Improvement (CQI) Sub-Committee

Mr. Whipple advised the CQI committee did not meet and a report would not be presented today.

2. Regional Education Planning Committee

Ms. Beggs delivered the REPC report. The committee met this morning. The Stroke Plan was discussed and will be presented later in the Business section. The Envenomation Plan was reviewed. The Trauma Plan was reviewed to discuss changes needed for air to ground communication. The air to ground changes will be brought up at the next quarters RTAB meeting for discussion and recommendation to send it to OTERAC. RTAB attendance was discussed.

C. Medical Emergency Response Center (MERC)

Ms. Beggs delivered the MERC report. FirstNet will be provided to First Responders on February 13, 2017 at 11:00 a.m. and 1:00 p.m. at the Pittsburg County Health Department. The new cooperative agreement for disaster preparedness and response is being filled out for the next five years.

VI. Business: (Discussion and appropriate action)

A. Oklahoma Trauma and Emergency Response Advisory Council Meeting Review

Dan Whipple delivered the review. The Trauma Referral Center TReC provided data for Regions 7 and 8 patient transfers. OTERAC is reviewing trends about improvement noted with keeping patients within their Regions and

continued reviews of patients transferred appropriately and correct any negative trends. New ways to improve the Oklahoma City on-call system was discussed. Trauma and Emergency Operative Licensure Surveys have resumed again. Trauma Regions, including Region 5 sent representatives to provided updates to OTERAC. St. Mary's has received their Level 2 Stroke Center verification. OU Medical Center and American College of Surgeons provided updates. Recommendations were made from ACS were made to help improve the Trauma System. ACS recommended that the Medical Audit Committee be brought back. Concerns with autopsies were discussed with the need to provide education to EMS agencies and hospitals around the State. Community Paramedicine was discussed with helping decrease hospital admissions. The need to provide blood screening for patient contaminants to help protect First Responders under the Good Samaritan rule was discussed. A statewide triage tag system was discussed. A defined age for trauma pediatric patients was discussed to align with ACS. The Region 5 stroke plan was submitted and not approved with timeline concerns. Through current legislation OTERAC does not have the authority to approve or deny the stroke plan for regional use. OTERAC operates in an advisory capacity. OTERAC advised the plan should go back the working group so neurosurgeons can discuss if patient priorities are appropriate. Sara Richmond, Delbert Gay and other Board Members shared their concerns about rural and metropolitan differences. Mr. Gay was advised that some physicians from the working group could not be convinced of the longer timelines.

B. Review of OTERAC and Associated Work Groups

Dan Whipple delivered the review. A database was purchased for the Stroke Registry from the Stroke Working Group recommendations. Minimum dataset information was discussed to be required for the Stroke Registry (Chelsea Bishop provided. The Data Working Group goal was to go through and review current fields either to use or create other fields.

C. Regional Stroke Plan – Vote To Approve Final Revisions

Chelsea Bishop started the discussion and encouraged participation from all members for the final review and approval of the Region 5 Stroke Plan. Sara Richmond advised Choctaw Memorial Hospital has Telestroke capabilities and has concerns with transporting patients to a Level 1 or 2 stroke facility when a closer facility may have the capability to treat with TPA. Dr. Robert Knight was introduced by Ms. Richmond and confirmed Telestroke capabilities. Mr. Gay stated the Stroke Plan would be a “living” document and would need to be reviewed and updated periodically. Ms. Bishop advised the plan should be reviewed and updated quarterly as updates are made by the Health Department on Hospital Stroke Classifications. It was reminded that patient choice is included in the plan.

Ms. Bishop opened up for discussion any changes to the following:

Patient Destination General Statement:

Priority 1 – No concerns.

Priority 2 – No concerns

Priority 3 – No concerns.

Patient Destination by County:

Atoka County – Mr. Gay had concerns about day to day hospital capabilities. Ms. Beggs is hoping to have all hospitals to level 3. Ms. Beggs advised the plan could not incorporate day to day capabilities.

Bryan County – No Changes

Choctaw County – Why does the plan have ambulances by-passing Paris, TX? Ms. Beggs advised when the plan was written Paris was not classified as a stroke hospital. The plan would be changed to show the Paris destination.

Coal County – No Changes

Hughes County – No Changes

Latimer County – No Changes

Leflore County – David Grovdahl stated Priority 1 should say Eastern Oklahoma Medical Center or Fort Smith and Priority 3 should say McAlester Regional or Mercy Fort Smith.

Marshall County – Changes need to made to Plano

McCurtain County – No Changes

Okfuskee County – No Changes

Pittsburg County – No Changes

Pushmataha County – No Changes

Seminole County – Mercy Ada needs to be added to Priority 1.

There was a question about patient choice to Tribal Hospitals. The Tribal Hospitals in Ada and Talihina are Level 3 facilities. There has been a last updated date added to the Stroke Center Designation page. If there are any changes to

Delbert Gay (Antlers) made a motion to approve the plan as a “living/breathing/accurate” document that will be changed and seconded by Kim Ross (International Paper). The motion passed unanimously after a roll call vote.

D. Discuss Regional Envenomation Plan

Chelsea Bishop advised the review of the plan would be tabled until the next meeting but a rundown of the plan would be presented today. Kari Beggs advised a rough draft was created and reviewed. The patients were prioritized to apparent envenomation, minor envenomation or dry-bite/no-bite. The hospitals were classified from information provided by the Board Members. Changes will be made to the plan provided in today’s packet after discussion in the REPC meeting. A process for snakebite divert will be discussed and added.

E. Add Dr. Karen Siren to CQI Subcommittee – Vote to Approve

A motion to approve adding Dr. Karen Siren was made by Kim Ross (International Paper) and seconded by Delbert Gay (Antlers). The motion passed unanimously after a roll call vote.

F. Discuss Telemedicine

Chelsea Bishop advised if a hospital provides Telemedicine it is not necessarily the hospital you have to transport patients too (Example: McAlester Telemedicine is connected with St. Louis. You do not have transport patients to St. Louis). Dr. Robert Knight advised he has 13 hospitals with capabilities of Telemedicine and provides care to patients who don’t need to be transferred.

G. Discuss Strategic Planning Meeting

Chelsea Bishop advised that the scheduled planning meeting did not take place. The planning meeting is designed to have representation from each part of the region to develop a plan for the next 2 to 5 years. If anyone is interested in participating please contact Chelsea Bishop.

A question of updating the form every year when there are no changes in the information. Daniel Whipple advised emailing or hand delivering forms is preferred. The forms are required annually.
