- I. Call to Order: Meeting called to order at 12:30 PM by Chair David Howerton.
- II. Welcome and Introductions: None
- III. Roll Call: Quorum Met
- IV. Approval of Minutes April 12, 2016: Motion made by Jason Likens of Samaritan EMS and seconded by Brad Faulkner of AllianceHealth Deaconess.
- V. Treasurer's Report: The balance of the Region 8 RTAB is 1443.47 with 2.00 being deducted monthly for a paper statement fee.

VI. Reports/Updates


- A. OSDH Emergency Systems: Brandon Bowen introduced a new member of Emergency Systems, Kellie Clark. Ms. Clark is the new Quality Survey Analyst and will be working on trauma and emergency operative services inspections and CQI trauma registry indicator cases. Revised TReC Quick Reference guides are available for hospitals and EMS. Changes that were made include additional considerations for upgrading Priority II to Priority I and additions to Priority I indications. For anybody interested, the Trauma Fund Coordinator position is open and can be found on the Oklahoma OK jobs website. Emergency Systems is again offering EMS Director Training. The training will be offered on a regional basis with the first training occurring July 27th in Region 1 at the High Plains Technology Center in Woodward, OK. This training is open to anyone who would like to attend and is not restricted to only Region 1 or EMS Directors. All trauma regions continue to work on stroke planning with draft stroke plans hopefully available in the next few months. The next OTERAC meeting will be held at the Metro Technology Center on September 7, 2016 at 1:00 PM. Their strategic plan remains to identify and treat all time sensitive medical conditions. The governor has signed the Omnibus bill which approved the proposed EMS Rules. The new EMS rules will be available September 7th.
- B. Continuous Quality Improvement Subcommittee: No report at this time. Heather Booher encouraged everyone to continue submitting cases.
- C. Trauma Rotation Subcommittee: A brief meeting was held discussing the status quo of the trauma rotation subcommittee for the last year and celebrating the minimization of conflict within the system. Meetings will be held twice a year or as needed. After the meeting adjourned, discussion was had to include capacity within the system to take care of Level I and Level II patients, the distribution of those patients, and the facilities working together with OSDH to facilitate that. A meeting will be scheduled within the next month to discuss changes to the rotation regarding INTEGRIS facilities. The proposed changes will be brought to the Trauma Rotation Subcommittee and then to the RTAB for approval.
- D. Regional Planning Subcommittee: The planning committee met to discuss stroke and a subcommittee was formed to begin stroke planning.
- E. TReC Update No update at this time. For any questions, contact Dan Oller or Brandon Bowen.
- F. RMRS Update Mike Murphy of RMRS discussed Medical Surge and defined the different types of incidents that may present to the medical system. He also provided information concerning the Medical At-Risk Individual/Patient and the criteria used to define this patient.
