## **Alternative Fuels Program and Legislative Updates**

Jim Williams, Director, Safety Standards Division reported on program updates. Jim stated that inspections in the northeast were in Miami, McAlester, Webber Falls, Broken Arrow, Claremore, Tahlequah and Arkoma. Reinspections occurred in Stillwater, Billings and Shawnee. Inspections in the northwest were in Norman, Oklahoma City and a new station that opened in Woodward. Jim also reported that stations have closed in Okemah, Poteau, and Elk City. There have been concerns from the public that there are very few CNG providers. They are still in discussion regarding the Bed Rock CNG/Hydrogen project. Jim also discussed some figures about licenses that are concerning. In the state we have 571 Compression Technicians licenses, however only 59 are active and 147 have expired. Another example is there are 1426 Equipment Technician licenses and only 107 are active.
