# Committee and public discussion regarding unwanted fire alarms in Tulsa, Tulsa's Community Risk Assessment, and Community Risk Reduction measures

Bryan Runyan, Assistant Fire Marshall from the city of Tulsa fire department discussed a strategy for community risk reduction through unwanted alarm reductions. The goal is to educate businesses on what to do when they receive an alarm on their alarm system to be able to either repair the panel themselves or call the alarm company for repairs instead of ignoring the alarm. They are asking companies to apply a QR code on their alarm system panels that can walk the company through correcting deficiencies and if unable to do so, to encourage them to get the alarm company to fix the system. This keeps companies compliant and saves resources being expended on false alarms.
