BayoTech Corporation maintains its composite-wrapped cylinders, which are manufactured in accordance with USDOT Special Permit SP-14576, meet or exceed the design and testing requirements of the ASME Pressure Vessel Code, which is the standard found under the Oklahoma Boiler and Pressure Vessel Safety Act. BayoTech Corporation advises it was granted a similar variance in California, CAL OSHA Variance 13-V-186, approximately ten (10) years ago.
