# 2022 ANNUAL AMUSEMENT RIDE PROGRAM REPORT

In accordance with Oklahoma's Amusement Ride Safety Rules, specifically Oklahoma Administrative Code ("OAC") 380:55-5-6(e), prior to the beginning of each calendar year, the Commissioner of Labor shall prepare a schedule of fees to be charged during the following year for the registration and inspection, by amusement ride type, of all amusement rides in this state. No fee shall exceed the maximum fee listed in this section for each amusement ride type. The fee schedule shall be posted on the Department of Labor's publicly accessible website and shall be made available at the office of the Department of Labor. The schedule of fees shall be accompanied by an explanation of the Amusement Ride Safety Program's revenue and expenses for the preceding fiscal year and the Amusement Ride Safety Program's expected revenue and expenses for the upcoming fiscal year.
