These are the minutes for the Corporation Commission’s (“Commission”) regular meeting conducted in accordance with the Open Meeting Act on April 14, 2022, in Room 301 of the Commission’s principal offices at 2101 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105. The notice and agenda for the meeting were publicly posted at the Oklahoma City offices of the Commission at 9:15 a.m. April 13, 2022, by Commission employees acting under the direction of Chairman Dana L. Cummings, Commission Secretary. Discussion was held. The Commissioners unanimously approved the proposed orders with the exception of CD2021-001607 and CD2022-001101, which were stricken.

Discussion was held. The Commissioners unanimously approved the proposed orders with the exception of PUD2022-000022 and PUD2022-000023, which were stricken.
