

**Minutes of the

These are the minutes for the Corporation Commission’s (“Commission”) regular meeting conducted in accordance with the Open Meeting Act on July 1, 2025, in the Concourse Theater, Suite C50, Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105. Archived Commission meeting recordings may be accessed on the Commission’s website.

The notice and agenda for the meeting were posted prominently and publicly at the principal office of the Commission at the Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105 at 12:00 p.m., June 27, 2025, by Commission employees acting under the direction of Chairman Kim David. Chairman David called the meeting to order at 1:33 p.m.

Members present were Chairman Kim David and Commissioner Brian Bingman. A quorum of the Commission was present. Commissioner J. Todd Hiatt was not present at the opening of the meeting, but he joined the meeting at 1:34 p.m. Interested persons participated in the meeting either in person or by teleconference/videoconference when and as authorized.
