May 1, 2025 – 9:30 a.m.

These are the minutes for the Corporation Commission's ("Commission") special meeting conducted in accordance with the Open Meeting Act on May 1, 2025, in the Concourse Theater, Suite C50, Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105. Archived Commission meeting recordings may be accessed on the Commission's website.

The notice and agenda for the meeting were publicly posted at the principal office of the Commission at the Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105 at 8:30 a.m., April 29, 2025, by Commission employees acting under the direction of Chairman Kim David. Notice was provided in writing to the Oklahoma Secretary of State at least forty-eight hours in advance of the meeting, and the notice and agenda are also made available to the public on the Commission's website, oklahoma.gov/occ. A copy of the notice and agenda is attached to these minutes as Appendix A.

Chairman David called the meeting to order at 9:30 a.m.

Members present were Chairman Kim David, Commissioner J. Todd Hiett, and Commissioner Brian Bingman. A quorum of the Commission was present. Interested persons participated in the meeting in person or by teleconference/videoconference when and as authorized.

Recognition of Employee Service The Commissioners gave recognition to employees for years of service in the employ of the State of Oklahoma. Brandy Wreath, director of administration, requested that the Commission return to this agenda item later in the meeting, because the final employee service award document was being prepared.

Commissioner David announced the agenda item and recognized Garey Wortham, commission secretary, to present the items for approval. Mr. Wortham announced that Commission staff requested that the proposed orders for Case No. CD2024-003268 and Case SF2025-000047 be stricken from the daily agenda. The Commissioners unanimously approved the remaining proposed orders.

Commissioner Bingman offered a revised version of the proposed *Order Granting Motion to Determine Notice Requirements and Approve Form of Notice* in Case No. PUD2025-000022. Discussion was held. Commissioner David and

Commissioner Hiatt agreed with substitution of the revised version of the proposed order for PUD2025-000022. The Commissioners unanimously approved the proposed orders.

The following item was taken out of order of the posted meeting agenda.


The Commissioners returned to agenda item II and gave recognition to one additional employee for years of service in the employ of the State of Oklahoma.
