These are the minutes for the Corporation Commission's ("Commission") regular meeting conducted in accordance with the Open Meeting Act on October 15, 2025, in the Concourse Theater, Suite C50, Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105. The notice and agenda for the meeting were posted prominently and publicly at the principal office of the Commission at the Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105 at 11:30 a.m., October 14, 2025, by Commission employees acting under the direction of Chairman Kim David. Chairman David called the meeting to order at 1:30 p.m.

Members present were Chairman Kim David, Commissioner J. Todd Hiett, and Commissioner Brian Bingman. A quorum of the Commission was present. Interested persons participated in the meeting in person or by teleconference/videoconference when and as authorized.

Mr. Wortham requested that Cara Parent, acting secretary, be permitted to present today's agenda items. The Commissioners were in agreement with this substitution. The Commissioners unanimously approved the minutes for October 1, 2025, at 1:30 p.m., and October 9, 2025, at 1:30 p.m., with the exception of Commissioner David's abstention on the October 1, 2025, 1:30 p.m. minutes, because she had not been present for that meeting.
