Commissioner Anthony,

I am writing as the Director, FIRES Innovation Science & Technology Accelerator (FISTA) in Lawton Fort Sill, Oklahoma and a retired Navy Captain (O-6) Surface Warfare officer that served on ships and submarines that used DFM boilers, LM2500 turbine engines and nuclear reactors. My family established its Oklahoma roots here in 1901.

My role in Economic/Business/Industrial Development is primarily to encourage businesses (defense and defense-related), academia, and innovators to operate in a culture of collaboration through bringing, growing and sustaining high-tech jobs here in direct support to Fort Sill and the U.S. Army's Futures Command Cross-Functional Teams.

My former role in the U.S. Navy provided me with the understanding and application of transferable skills, training and management of natural resources and current as well as advanced technologies in operating prime movers from across the engineering enterprise around the globe on the surface of the world's oceans and in the littorals as well as in the bathysphere. I understand the purpose and application of diversified energy resources and its means to provide for greater efficiencies as well as alternate forms of sustainable energy.

There are many great opportunities in energy for southwest Oklahoma that may be better than we could ever imagine. Economic development continues to move forward, and more businesses are looking to expand here. Fundamental to this success is making sure our core business sector can remain strong and has the chance to build, grow, and sustain with future needs. Adding to this success is a brand-new project that will strengthen economic development, bolster the great work at Fort Sill and add clean energy back to the grid. You may have heard some about it in the news: It is often referred to as the Fort Sill Solar project. Ft. Sill and Public Service Company of Oklahoma have combined forces to build a 10.9 MW solar farm and a 36 MW

Reciprocating Internal Combustion Engine (RICE) generating facility on Fort Sill just off Rogers Lane in Lawton.

The project is a sustainable winner for Fort Sill and PSO, because it would allow Fort Sill to operate, in case of an emergency, for 14 days without being connected to the standard electric grid. PSO customers win by having more clean energy generated and put back on the electric grid, providing reliable low-cost electricity.

The concept, already in practice, takes the best of joining renewable energy with the clean-burning advantages of natural gas. This project, we believe, will work as a blueprint for other military installations across the country, making the Fort Sill project a model for others, who want to do public/private ventures with the military.

The importance of this project will help further Business Development efforts to the Fires Innovation Science & Technology (FISTA) which is going in at the repurposed Lawton mall. Because economic developers are increasingly looking for communities with clean energy options, the Fort Sill solar project would supply up to 46.9 megawatts of additional power, increasing the opportunities for expanded area economic development growth.

The project is crucial for Oklahoma Corporation Commission (OCC) active support and approval. I strongly encourage OCC board quick action to vote in support of this project is of vital importance to the strength of Fort Sill and the economic development of Southwest Oklahoma.

Your support of this project is very important. Thank you for your time and consideration of this matter.
