Directive issued for disposal well shut-in and volume reductions in Crescent area

Because of recent earthquake activity in the Crescent area of Logan County, the Oklahoma Corporation Commission's Oil and Gas Conservation Division (OGCD) has issued a directive for specified oil and gas wastewater disposal wells to cease operations (shut-in) and for further reductions in other disposal well volumes.

The directive applies to those disposal wells in the prescribed area that inject into the Arbuckle formation. Researchers are in broad agreement that disposal into the Arbuckle formation in Oklahoma poses the largest potential risk for induced seismicity.

Under the directive, three currently operating disposal wells will cease operations ("shut-in"). One other disposal well will not be allowed to resume operation. These wells are within 0 to 3 miles of the earthquakes' location.

For Arbuckle disposal wells operating within 3 to 10 miles of the location, average daily volumes above 500 barrels per day will be reduced 20 percent. This is in addition to past directives that reduced volumes.

Based on the last 30 day average, this action is calculated to result in an overall further reduction in Arbuckle disposal of 2,848 barrels per day.

Further, operators of those wells which have reduced their depth to avoid injecting too close to the basement rock will be required to verify the well's bottom hole plug integrity.

The directive applies to 25 disposal wells in total, 20 of which have operated within the last 30 days.

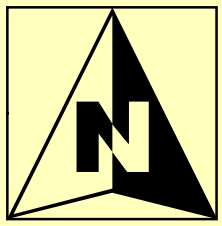

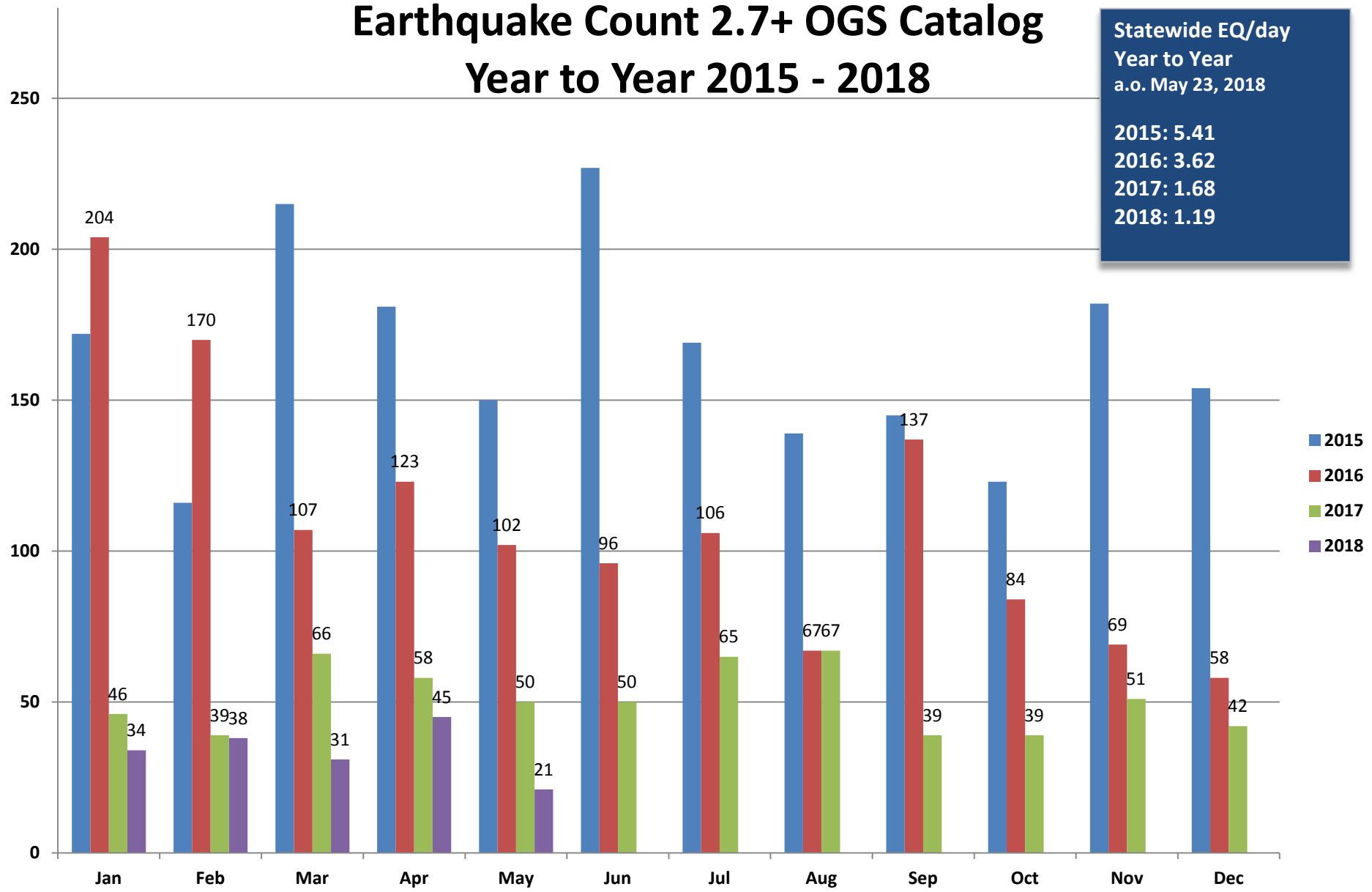

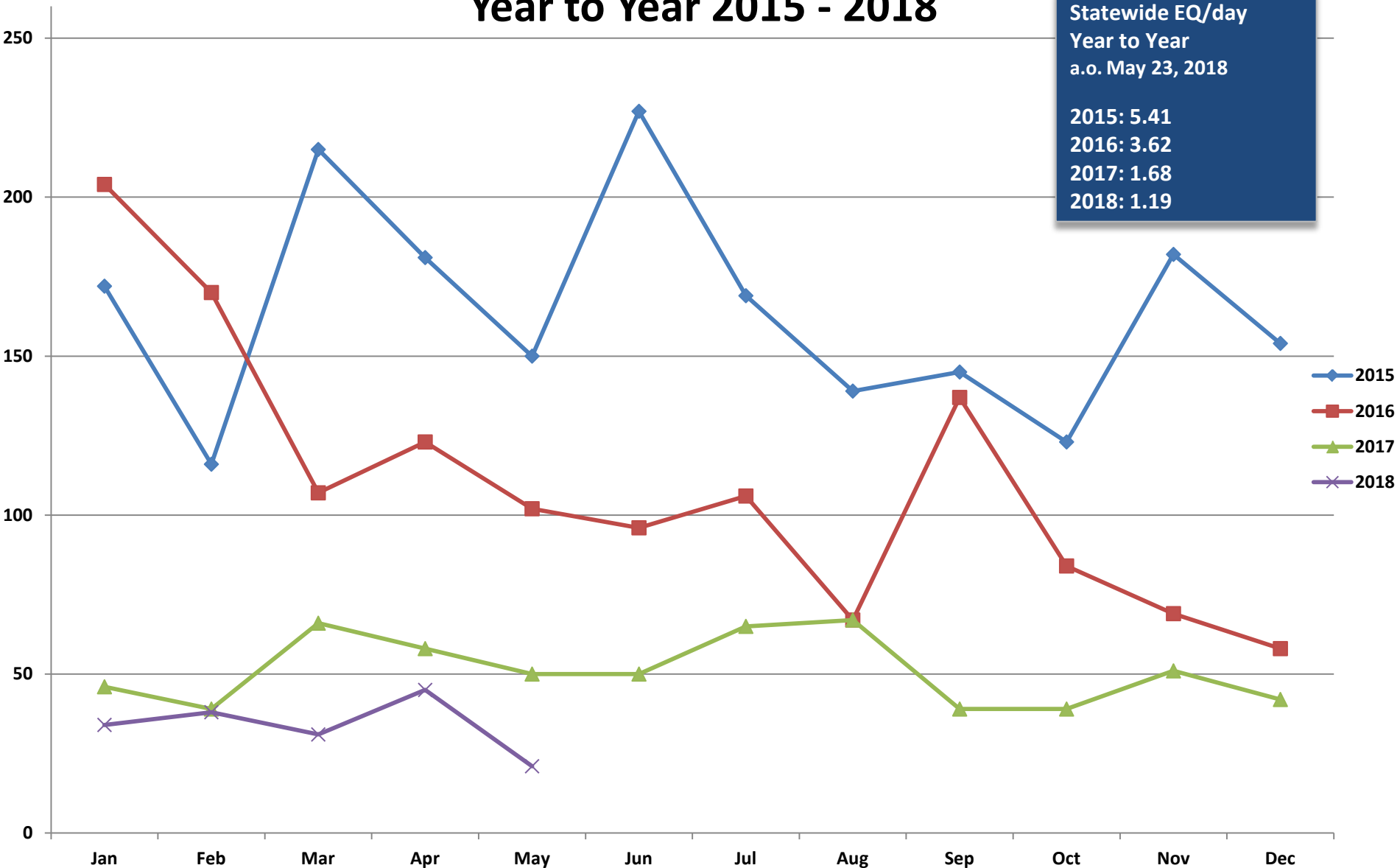
