SUMMARY OF MOTIONS AND ACTION ITEMS

MOTION: To approve the minutes from August 5, 2024.

Randel Christmann (ND PSC) motioned / Chuck Hutchinson (NPRB) seconded. *The motion passed unanimously*.

MOTION: Approve the slate of 2025 Regional State Committee Officers as presented.

Andrew French (KCC) motioned / Mike Francis (LPSC) seconded. *The motion passed unanimously*.

AGENDA ITEM 1 - CALL TO ORDER

President John Tuma (MN PUC) called the meeting to order at 1:01 p.m. CT.

b. Adoption of Minutes

Randel Christmann (ND PSC) motioned / Chuck Hutchinson (NPRB) seconded. *Motion passed unanimously*.

 - Item 23, HITT M1 Staff will continue to evaluate and work with the CAWG, and an update will be provided to the RSC at the February 2025 meeting.
- d. <u>Introduction of Special Guests</u> John Tuma (MNPUC) introduced and welcomed Arizona PSC Commissioner Nick Meyers, Wyoming PSC Commissioner Mike Robinson, and FERC Staff.

AGENDA ITEM 3 – UPDATE

- a. <u>SPP Report</u> Barbara Sugg (SPP) welcomed Kim David from the OCC to her first RSC meeting as an official RSC member. Ms. Sugg also welcomed several guests, including Commissioner John Harvey from Utah and Melanie Frye, the CEO of the Western Electricity Coordinating Council. Ms. Sugg thanked the RSC for its continued work on resource adequacy and cost allocation and acknowledged the CAWG's work on HITT C1. Ms. Sugg noted that SPP has provided notice to begin the FERC Order 1920 engagement period. Ms. Sugg also commented on the Our Generational Challenge paper and noted that it is being used in DC and other states to educate legislators and policymakers. Ms. Sugg thanked Commissioner John Tuma for his RSC leadership.
- b. <u>RSC Third Quarter 2024 Financial Report</u> Paul Suskie (SPP) reviewed the RSC quarterly financials for the 3rd quarter of 2024. Mr. Suskie noted overall actual expenses are below budgeted amounts, but actual expenses for Meetings are over budget due to higher-than-expected expenses from the St. Louis RSC meeting and the meeting that occurred during the MARC conference that was not originally contemplated in the budget.

Lise Trudeau (MN PUC) provided an update on the Cost Allocation Working Group (CAWG). Ms. Trudeau reviewed CAWG voting results from the previous quarter and presented the following for RSC consideration:

a. HITT C1: Decouple Schedule 9 & 11 Pricing Zones

MOTION: Approve the decoupling of Schedules 9 and 11 and the establishment of larger Schedule 11 zones (subregions) as approved by the CAWG.

Andrew French (KCC) motioned / Pat O'Connell (NM PRC). The motion passed with 8 votes in favor, 4 against (APSC, LPSC, OCC, PUCT), and 0 abstentions.

b. Seams Projects Policy Paper

MOTION: The RSC continue to endorse the Seams Projects Policy Paper as meeting established RSC policies on Seams cost allocation and move forward with the approved SCRIPT recommendation to seek FERC approval to include in the SPP Tariff.
