

LEGAL NOTICE

Pursuant to Oklahoma Senate Bill 808, on September 3rd, 2015 Apex Clean Energy, on behalf of Grant Plains Wind, LLC, mailed the notice of intent copied below to the Oklahoma Corporation Commission.

NOTICE OF INTENT TO CONSTRUCT

In order to comply with the requirements of Section 2 of Oklahoma Senate Bill 808 ("OK Siting Laws"), which was approved by the legislature and signed by the Governor, and in advance of certain rules that are to be promulgated by the Oklahoma Corporation Commission ("Commission") pursuant to the passage of SB 808, Apex Clean Energy ("Company"), on behalf of Grant Plains Wind, LLC, hereby informs the Commission of its intent to construct the Grant Plains Wind energy project (the "Project") located in Grant County, Oklahoma.

The Project has been under active development for several years. The most recent FAA form 7460-1 filing was made on August 17, 2015. A summary of the August 17, 2015 FAA form 7460-1 filings for each wind turbine tower location within the Project boundary is attached as Exhibit A. Exhibit B to this letter presents a diagram showing the real estate analyzed and included in statutory setback compliance. As of the date of this notice, and based on publicly available data, Company attests that the Project design complies with the setbacks required by the OK Siting Laws.

In accordance with the OK Siting Laws, Apex Clean Energy also confirms it is submitting a notice of intent to construct to the Board of the Grant County Commission in the form attached hereto as Exhibit C. No project facilities are located within an incorporated area of a municipality, and thus no additional notice is required under SB 808.
