Pursuant to the Oklahoma Wind Energy Development Act ("Act") and the Oklahoma Corporation Commission ("OCC") rules implementing the Act, this letter is a notification of intent to build a wind energy facility ("Notice"). We intend to construct wind energy turbines and related facilities for the Pontotoc Wind Energy Project in Pontotoc County, Oklahoma (the "Project"). Notice is being provided to you within six (6) months of the initial filing of the Notice of Proposed Construction ("7460-1 Forms") with the Federal Aviation Administration ("FAA"), made on April 11, 2023.

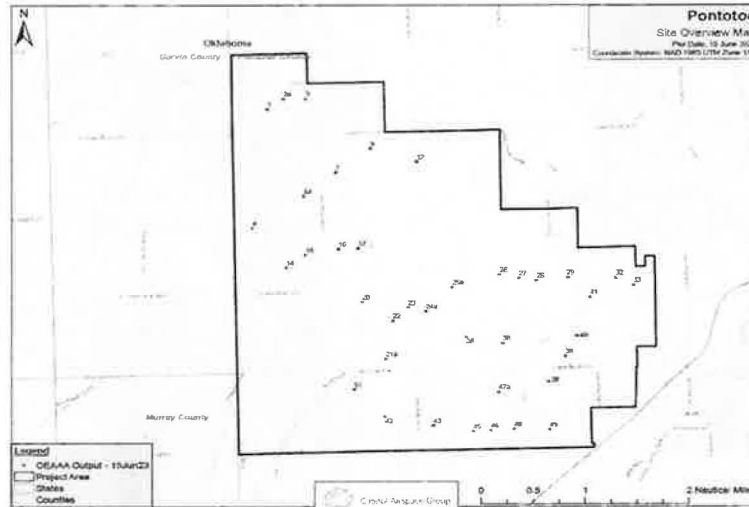
Enclosed as **Exhibit A** to this Notice are copies of all the initial 7460-1s Forms for each wind turbine, met tower, or other structure that requires such form that is a part of the Project. A map depicting the Project boundary is included with this Notice as **Exhibit B**. As of the date of this Notice, and based on publicly available data, we confirm that the Project design complies with the setback requirements set forth under section 17-160.20A of the Act.

Within twenty-four (24) hours of submitting this Notice to you, we are providing copies of this Notice to the Pontotoc Board of County Commissioners. No portion of the Project is located within an incorporated area of a municipality.

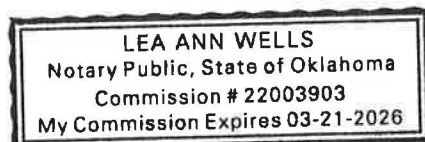
