



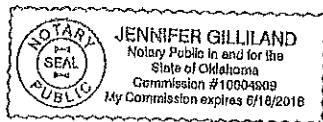

In order to comply with the requirements of Section 2 of Oklahoma Senate Bill 808, codified as Section 160.21 of Oklahoma Statutes Title 17, (collectively referred herein as "OK Siting Laws"), which was approved by the legislature and signed by the Governor, and in advance of certain rules that are to be promulgated by the Oklahoma Corporation Commission ("Commission") pursuant to the passage of OK Siting Laws, NextEra Energy Resources, LLC, (the "Company") hereby informs the Commission of its intent to construct the Minco V wind energy project (the "Project") located in Caddo County, Oklahoma. During the course of this project planning and development it has been referred to as Minco IV Expansion and Minco V and will continue to be referenced as such to mean the same project as outlined in the Project Boundary found in Exhibit B.
