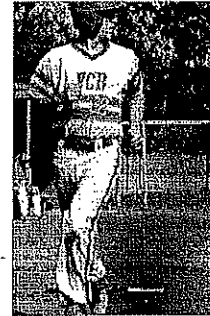



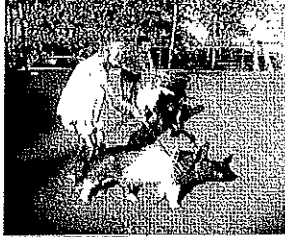
Jarrett Watkins won Reserve Breed National Wether and Champion Breed Hampshire Wether.



# Police Probe Brawl That Killed Student After Party

ITHACA, N.Y. (AP) — An Ithaca College student fatally stabbed at Cornell University was attacked while trying to help a fellow student amid a series of fights after a weekend party, his sister said Monday.

Anthony Nazaire, a 19-year-old sophomore from New York City who was majoring in business administration, and his friend were stabbed early Sunday as several hundred people were leaving a fraternity-sponsored party at the Cornell student union, authorities said.

Police haven't said what triggered the fight.

Klara Nazaire said she had spoken with her brother's friend and was told her brother was trying to get him away from a confrontation when their assailant struck.

"He was defending his friend," she said, fighting back tears outside her family's apartment. "It wasn't to fight. He was pulling him away — and the coward just attacked them."

Nazaire said her brother had been visiting friends at Cornell and had developed an "apostate New York family" there.

She said her family went to Ithaca on Sunday but returned early Monday with little information from investigators about their progress.

"I know the cops are going to do everything they have to do to make sure Anthony is at peace," she said. "We know justice is going to be served."

Police have not named any suspects in the stabbing, which followed a Saturday night party organized by Omega Psi Phi, a national fraternity of black men, at Willard Straight Hall as part of a series of events under the umbrella of Cornell's Black Students United group. Other

Say It Loud 2016 events included orientation sessions for incoming black students, ice cream socials, a Labor Day weekend barbecue and a guitar night.

Investigators said they were interviewing witnesses and believe based on surveillance footage that some captured the killing on video.

Ithaca College President Tom Rochon said Anthony Nazaire graduated from Brooklyn Theatre Arts High School and was a member of the executive board of Brothers4Brothers, an Ithaca College student organization.

"dedicated to empowering men of color on our campus."

About 300 people filed a memorial service on campus, where students described Nazaire's ever-present smile and determination to succeed as an entrepreneur.

Joylen Young said his friendship with Nazaire began when Nazaire spotted his Brooklyn Nets hat.

"I've lost friends to gang violence, drug dealers," Young said. "He was never like that. He had goals and plans."

Minutes before Nazaire

died, Young had gone to get the car, leaving his friend to wait for him on the corner, he said.

"Anthony, I'm so sorry," he said. "I wish we could have got there a few minutes earlier."

Rochon described Nazaire's mother packing up his belongings and driving back to Brooklyn just nine days after helping unpack them in anticipation of the new school year.

After the service, as students hugged and cried, Rochon said he was proud of the nail-video message that was a recurring theme of the service.

"We have a shared humanity, we have a shared vision of our future lives and were going to work on this together," Rochon said.

Earlier Monday, outside the student union at Cornell, senior Sonya Quamr said the killing was unsettling.

"There's the typical occasional break-in where a laptop is stolen or someone gets their wallet stolen out of the library, but it's completely different when it's someone getting stabbed outside one of your favorite libraries," she said.

# Man Charged in Oklahoma Slaying Also Indicted in 2 Texas Slayings

**GALVESTON, Texas (AP)** — A man already charged with abducting and killing a 19-year-old woman in Oklahoma was indicted Thursday in the 1997 slayings of two girls in Texas.

A Galveston County grand jury indicted William Lewis Reece on murder counts in the deaths of 12-year-old Laura Smither of Friendswood and 17-year-old Jessica Cain of Tiki Island.

Reece was already serving a 60-year prison sentence in Texas for kidnapping earlier this year when he led police to graves where remains were found of Cain and Kelli Cox, a 20-year-old University of North Texas student who was last seen in Denton in 1997.

The 37-year-old registered sex offender is charged in Oklahoma with first-degree murder and kidnapping in the 1997 death of 19-year-old Tiffany Johanson.

Galveston County District Attorney Jack Ready said Reece wouldn't be tried in Galveston until the Oklahoma case was resolved.

The murder indictments were sought because insufficient evidence had been gathered to support capital murder indictments, Ready said.

Previously, Reece's attorney, Anthony Ossa, had said his client had hoped to avoid the death penalty by cooperating with authorities.

# Lawton Man Pleads Guilty in Roommate's Stabbing Death

**LAWTON, Okla. (AP)** — A Lawton man has pleaded guilty in the stabbing death of his roommate.

Court records show 30-year-old Sigfredo Sisco pleaded guilty Tuesday to second-degree murder, unlawful removal of a dead body and desecration of a dead body in the June 2015 death of 28-year-old Trevor Boyer at the home they shared in south Lawton.

Boyer's body was found buried beneath a shed behind the house.

Investigators have said Boyer was stabbed during a fight with Sisco.


Sisco initially told police Boyer stabbed himself to death after an argument and that he had buried the body because he was scared.

# Police catch mower thief in the act

## Officers find suspect trying to load a stolen lawn mower onto a trailer at Tractor Supply with a stolen vehicle

# Mustang police looking to procure three new vehicles

Over the past couple of years, the Mustang Police Department has used a simple and effective process to procure new vehicles. This process will now change, however, according to Police Chief Chuck Foley. "We have enjoyed favorable past years of vehicle procurement through the use of municipal lease-purchase financing that has provided low finance rates," Foley said. "Additionally, police will have been able to locate the needed police package vehicles in stock at

metro dealerships holding the same contract for this class of vehicles. This worked to our advantage by having the Vehicle Identification Number (VIN) known and available to include in all the lease documents presented to the City Council in advance for approval to proceed." However, new things have changed in the police market, Foley said. "Now, the dealership holding the best, least expensive vehicle needed for our purposes is with a non-stocking dealership that just has a government sales office in the Oklahoma City metro," he said. "Since

the dealership does not have stock, VIN numbers are not available for the basic documents to present as a Council agenda in advance of the approval to proceed." Foley said the cutoff date to order 2017 vehicles at 2016 prices is Sept. 14. "To address this problem, Mustang is being allowed to issue a Purchase Order for three vehicles just to place the order for the purpose of getting the VIN," he said. "The VIN will be supplied by the dealership in three to six weeks after the receipt of the Purchase Order." Foley said once the VIN is received, it will be



The Mustang Police Department has used a municipal lease-purchase financing program to obtain vehicles in recent years. furnished to the bank and a complete municipal lease-purchase document package will be presented to the City Council before delivery acceptance of the vehicle. "Once the City Council gives us approval, the Purchase Order will be canceled and replaced with the municipal lease-purchase agreement and things will move forward as it has in previous years," he said.

From Page 1A of Oklahoma Planning Department. This time, the City hired a consulting firm, Hall Associates, to help with the update. The firm will be sending citizens a survey with their utility bills to get insight on their thoughts during the process. "We want to get as

much feedback as we can from the public so we can use that data to develop the plan," Helset said. "The total budget for the project, over two fiscal years, is \$120,000." The survey will ask residents their personal perspective about the City of Mustang, its current development, transportation systems and open space areas.

Associates in their survey. "Your responses will be used to help us imagine Mustang's future." Hall Associates is asking residents to return their filled-out survey to City Hall by Nov. 1. Along with the survey, a two-day public input meeting has been scheduled for Oct. 5 and Oct. 6 at Town Center. "People can come and go and give feedback

about the plan," Helset said. "There will be a presentation both that Wednesday and Thursday at 7 p.m. and daytime meetings will be open from 9 a.m. to 7 p.m." Lastly, Hall Associates will have a booth set up at Western Days collecting input from citizens and answering questions about the process.
