## **Attention ADSAC Providers,**

Beginning March 5, 2018, ODMHSAS will change the way in which CEU trainings for ADSAC assessors and facilitators are provided throughout the State by the ODMHSAS ADSAC Division.

Trainings will continue to be held in Oklahoma City and Tulsa but will now be combined into one-day trainings with four hours devoted to assessor material in the morning and four hours devoted to facilitator material in the afternoon. The ODMHSAS CEU trainings for assessors will focus on application and use of ASAM, DRI, DQ, NEEDS, and TAAD. Trainings for facilitators will focus on facilitation skills. **Trainings will now cost \$135 for a full day, or \$67.50 per four hour session.**

Additionally, these trainings will continue to be offered at the annual ODMHSAS Prevention and Recovery Conference. However, the ADSAC Division will no longer have an early bird registration for a free conference day.

It continues to be the responsibility of the assessor/facilitator to ensure that they receive all CEU hours required for certification renewals, even if they are not directly provided by the ODMHSAS ADSAC Division. If there are any questions about whether an ODMHSAS sponsored training or a non-sponsored training meets the CEU requirement, the ODMHSAS ADSAC Division may be able to advise based on the amount of information on the training that can be provided. The required CEUs are as follows:

### **Assessors**

- Application and use of the following (4 hours)-ASAM, DRI, DQ, NEEDS, and TAAD
- Evidence based interview techniques (4 hours)
- General substance abuse (2 hours)

## Facilitators

- Adult education (4 hours)
- Facilitation skills (4 hours)
- General substance abuse (2 hours)
