**DISCUSSION REGARDING REPORT FROM COMMISSIONER**

2014 Spring Specialty Court Judges' Forum – Commissioner White spoke at the Spring Specialty Court Judges' Forum, which is hosted by ODMHSAS. This semi-annual event is important because it gives the judges an opportunity to

come together and discuss Drug Court. There were over 20 Drug Court judges in attendance.

2014 Drug Court/Mental Health Court Day at the Capitol; My Mind Matters Day at the Capitol, Hosted by the Coalition of Advocates; 2014 Children, Youth & Families Picnic Celebration; and My Mind Matters, Hosted by the Coalition of Advocates Reception Dinner – Commissioner White highlighted these annual events that took place at the Capitol, which provides an opportunity to have legislators in attendance. She spoke about how these events show the need for funding mental health and substance abuse services.

2014 Suicide Prevention Conference – This conference started the day before this Board meeting. Commissioner White gave the opening address. There were around 400 people in attendance focused on preventing suicide.

Johnny McMahan, Editor, Woodward News; Journal Record Editorial Board; Lawton Constitution Editorial Board; The Edmond Sun Editorial Board; Ken Johnson, KOKC Radio; Tulsa Business Journal Editorial Board; Norman Transcript Editorial Board; Daily Ardmoreite Editorial Board; Chris McKinnon, Channel 9 News; Enid News Editorial Board; Muskogee Phoenix Editorial Board; Tulsa World Editorial Board – Commissioner White gave several interviews with the media and spoke at several editorial boards regarding the importance of mental health and substance abuse services.

Oklahoma City Economic Roundtable – Commissioner White spoke at this group's meeting about why mental health and substance abuse services matter to their business in regards to having a healthy workforce. It is hoped that this will increase interest from the business community in what they can do for their workforce.

Representative Scott Martin; Denise Northrup, Chief of Staff to Governor Mary Fallin; Steve Mullins, General Counsel to Governor Mary Fallin; Terry Cline, Ph.D., Secretary of Health and Human Services and Commissioner, Oklahoma State Department of Health; Brian Downs, Chief of Staff, House of Representatives; Representative Earl Sears; Representative Scott Martin; Representative SC Martin; Representative Dr. Doug Cox; Representative Tommy Hardin; Representative Gary Banz; Major General Rita Aragon, Secretary of the Oklahoma Department of Veterans Affairs; and Steven Buck, Deputy Commissioner, Communications and Prevention Services, ODMHSAS – These meetings focused on Commissioner White spending a great deal of time at the Capitol working on the budget.

OKC Metro Prescription Pain Medication/Heroin Symposium, sponsored by DEA OKC, OBND, OCPD, and the TEXOMA HIDTA – Commissioner White spoke at this symposium about the issues of prescription painkillers and heroin abuse and

the importance of prevention. Law enforcement has embraced this issue and worked with the Department on a couple of pieces of legislation this year.

Lieutenant Detective Patrick Glynn, Quincy Massachusetts Police Department; Tulsa County First Responder Opioid Overdose Training of Trainers – The Department is conducting a pilot program in Tulsa County that trains first responders such as police officers and fire fighters to administer naloxone to individuals who have overdosed. It forces them to breathe until they can get medical help. The first training in Tulsa was conducted by Lieutenant Detective Patrick Glynn from the Quincy Massachusetts Police Department which is one of the leaders in the nation in using the opioid overdose reversal kits. The Tulsa Police Department has already saved their first life using naloxone. ODMHSAS is looking to expand the program into other counties around the state including Oklahoma County.

ODMHSAS Board Member Confirmation – Stewart Beasley, Jr., Ph.D; ODMHSAS Board Member Orientation – Stewart Beasley, Jr., Ph.D. – Commissioner White highlighted the confirmation and orientation of the Department's newest Board member.

2014 ODMHSAS Public Service Recognition – Commissioner White reviewed how the Department's facilities and central office honored its employees for their service.

#### **DISCUSSION REGARDING REPORT FROM CHIEF OPERATING OFFICER**

Durand Crosby, Chief Operating Officer, announced that our Children's Conference will be held June 24-26, 2014, at the Embassy Suites in Norman, Oklahoma.

Mr. Crosby stated that ODMHSAS participated in the Oklahoma Quality Team Day program again this year. This program gives our facilities and divisions the opportunity to showcase their performance improvement projects. This year, ODMHSAS had 23 of the 61 projects that were submitted. The Department won 14 Governor's Commendations. There will be a presentation of those projects at the next Board meeting.

Mr. Crosby turned the floor over to Deputy Commissioner Steven Buck to discuss current legislation. Deputy Commissioner Buck had the following to report:

ODMHSAS had three request bills that were signed into law. One of the bills allows any Mental Health Court judge to order progressively increasing sanctions or provide incentives when relapses and restarts occur rather than removing the participant from the program and sending them to the Department of Corrections. Previously, the statute did not allow for relapses.



Another request bill allows the Department to sell a specific tract of land and use the proceeds for infrastructure improvement. There is nothing definite happening yet in regards to selling the land. This bill just allows ODMHSAS to start looking into the possibilities.

The last request bill was our Telemedicine bill. The Corporation Commission provides funding to support specific entities use of telemedicine as part of the mental health and substance abuse service array. A technical cleanup was needed to preserve that access for our providers.

Deputy Commissioner Buck also reported on the budget agreement that included a pay raise for some ODMHSAS' employees but not all of them.

Commissioner White reported on the Department's latest effort to acquire a new building to be housed along with the Department of Veterans Affairs. It was not successful, but we have been assured that this will be a priority for the Legislature next session.

**DISCUSSION REGARDING THE REPORT FROM THE PERFORMANCE IMPROVEMENT COMMITTEE**

Dr. McCaffree presented the report from the Performance Improvement Subcommittee held on Wednesday, May 14, 2014.

There were two presentations for the May meeting.

Michelle Bugg, Regional Prevention Coordinator, Red Rock West Yukon and Lauren Greenfield, Regional Prevention Coordinator, Red Rock West Clinton presented Responsible Beverage Sales and Service (RBSS) Training: An Evidence-Based Approach to Reducing Underage and High Risk Drinking. The presenters explained the content and purpose of RBSS and how it impacts alcohol retailers in the state and in their communities. The presentation also highlighted policy work, efforts for sustainability, and how high risk establishments are identified and approached.

The second presentation was by Tracy Leeper, Decision Support Policy Analyst for the Department.

Her presentation was entitled: "Impacting Suicides in Oklahoma: A First Glimpse at the Data."

Ms. Leeper stated that a preliminary examination was completed on 18 months of suicide deaths in Oklahoma. A small sample showed that 26% of the decedents had received some type of publically funded healthcare service, and the types and amounts of services could be mined. Of these individuals, 57% had received a service within six months of their deaths. The average number of days from the last service to the date of death was 36.5 days. Twenty-three

percent had seen a primary care clinician on the day they committed suicide and 46% had been seen within a week of their deaths. The length from last service to date of death for decedents seen at behavioral health treatment facility was much longer at 112.5 days.

The group discussed the fact that many people who have behavioral health issues seek treatment from their primary care providers and there is reluctance by some medical staff to ask about suicidality. Activities to educate primary care staff, as well as school employees and the general public, on the importance of talking about suicide need to be continued.

There was no further business discussed.

### **DISCUSSION REGARDING THE REPORT FROM THE FINANCE COMMITTEE**

Mr. Crosby presented the report from the Corporate Accountability meeting on behalf of Dr. Haynes who was unable to attend today's Board meeting.

The Finance Committee met on May 21, 2014.

Mr. McCann presented the finance report for the month ending April 2014. He presented the budget to actual comparison report as follows:

Revenue collections are trending below projections by \$9.4 million.

Expenditures are under budget by \$17 million or 4%.

The year-to-date net variance for the agency is a positive \$7.8 million or 2%.

Mr. McCann presented budget revisions 6, 7, and 8 that had been processed since the last Finance committee meeting. The three budget revisions were primarily operational changes to the budget and the overall net change was a \$563,000 increase to the agency's budget. Details of the revisions consisted of a

\$285,000 increase to the Substance Abuse block grant budget and a \$273,000 increase for asbestos/mold removal at Central Oklahoma.

Commissioner White updated the Board members regarding the FY15 Budget appropriations. She stated that the agency needed \$21 million above what the agency got last year to maintain services. The needed increase included Systems of Care funding, Drug Court funding, Disproportionate Share funding, changes in Medicaid funding, growth in need for behavioral health services, and growth in people signing up for Medicaid that were not previously signed up.

While ODMHSAS did not receive any budget cuts, the Department did not receive the additional \$21 million needed. ODMHSAS received \$2.2 million in new revenue for the FY15, \$1.2 million was earmarked for targeted employee pay increases and the remaining \$1 million is for 174 unfunded drug court slots and Systems of Care services. Unfortunately, it means that the Department will be making some significant cuts. The goal is to make cuts that affect the least number of people or in the least severe manner.

**Mental Health First Aid**

- 20 Countries since 2000
- 2008 MHFA comes to the USA
- 250,000 trained in the USA
- 4,000 Certified instructors in the USA
- 8 state funded programs (OK included)

**Mental Health First Aid Is . . .**

- Help offered to a person developing a mental health problem or experiencing a mental health crisis.

- Given, until appropriate treatment and support are received, or until the crisis resolves.
- Not a substitute for counseling, medical care, peer support, or treatment.

#### Mental Health First Aid – the Evidence

- Increase knowledge of signs, symptoms, and risk factors of mental illnesses and addictions.
- Ability to identify multiple types of professional and self-help resources for individuals with a mental illness or addiction.
- Increase confidence in and likelihood to help an individual in distress
- Show increased mental wellness themselves.

- Effective November 1, 2008

#### Mental Health First Aid – Youth Pilot




**NEW BUSINESS**
